Pursuant to Joint Rule 20, the full title of the act shall be inserted to read as follows:

“An act to create a commission for the control of the alcoholic beverage traffic within this state, and to prescribe its powers, duties, and limitations; to provide for powers and duties for certain state departments and agencies; to impose certain taxes for certain purposes; to provide for the control of the alcoholic liquor traffic within this state and to provide for the power to establish state liquor stores; to prohibit the use of certain devices for the dispensing of alcoholic vapor; to provide for the care and treatment of alcoholics; to provide for the incorporation of farmer cooperative wineries and the granting of certain rights and privileges to those cooperatives; to provide for the licensing and taxation of activities regulated under this act and the disposition of the money received under this act; to prescribe liability for retail licensees under certain circumstances and to require security for that liability; to provide procedures, defenses, and remedies regarding violations of this act; to provide for the enforcement and to prescribe penalties for violations of this act; to provide for allocation of certain funds for certain purposes; to provide for the confiscation and disposition of property seized under this act; to provide referenda under certain circumstances; and to repeal acts and parts of acts.”

Pursuant to Joint Rule 20, the full title of the act shall be inserted to read as follows:

"An act to provide procedures to determine the paternity of children in certain circumstances; to allow acknowledgments, determinations, and judgments relating to paternity to be set aside in certain circumstances; to provide for the powers and duties of certain state and local governmental officers and entities; and to provide remedies;"

The House agreed to the full title.

Rep. Garcia moved that the bill be given immediate effect.

The motion prevailed, 2/3 of the members serving voting therefor.

Rep. Hooker, having reserved the right to explain his protest against the passage of the bill, made the following statement:

"Mr. Speaker and members of the House:

I am completely against a rapist having the ability to have any rights to a child conceived in a true rape. Unfortunately, the wording in the bill used 'clear and convincing evidence' which leaves some room for a marital relationship that is

deteriorating, once a child is conceived, to convict a husband of non-consenting sex and causing him to lose custody of a child born from that relationship. I believe that a couple, that I know, who had a child born of a statutory rape situation accused by a parent could remove all parental rights to a young man or woman who had relations with a willing young person, who was below the age of 16 but he/she may have even initiated the relationship. A 'Romeo and Juliet' type of situation that resulted in a conception. Because this bill didn't consider these situations, I voted No. I truly am pro-life with a wife, daughter and four granddaughters who I want safe from a true rapist."

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 2567 (MCL 600.2567), as amended by 2004 PA 538.

The substitute (H-1) was not adopted, a majority of the members serving not voting therefor.
