## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 811a. (1) A motorcycle safety course required under
  section 312b conducted by a college or university, an intermediate
  school district, a local school district, a law enforcement agency,
  or any other governmental agency located in this state shall be
  conducted under this section.
  - (2) Except for motorcycle safety courses conducted under section 811b, an applicant for a motorcycle safety course shall pay not more than a \$25.00 \$50.00 course fee. The course fees shall be used only for funding the administration and implementation of the motorcycle safety education program.

- 1 (3) The secretary of state is responsible for the
- 2 establishment and administration of motorcycle safety courses and
- 3 shall promulgate rules pursuant to UNDER the administrative
- 4 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328,
- 5 regarding teacher qualifications, reimbursement procedures, the
- 6 establishment of the courses, and other requirements under this
- 7 section.
- 8 (4) The secretary of state shall designate a person to be the
- 9 state coordinator of the motorcycle safety education program. The
- 10 person designated under this subsection shall successfully complete
- 11 a motorcycle safety rider coach course before being designated.
- 12 (5) The position of state coordinator of the motorcycle safety
- 13 education program shall be funded by the motorcycle safety fund.
- 14 (6) The secretary of state shall designate a person who has
- 15 successfully completed a motorcycle safety rider coach course to
- 16 perform annual inspections of motorcycle course sites.
- 17 (7) An 8-hour motorcycle safety course that meets the
- 18 standards established by the secretary of state may be offered to
- 19 an applicant who has passed a motorcycle operator skill test that
- 20 has been approved by the secretary of state. Successful completion
- 21 of a motorcycle safety course under this subsection shall fulfill
- 22 the waiver requirement of section 312b.
- 23 (8) An audit of the motorcycle safety fund shall be conducted
- 24 by the office of the auditor general to determine compliance with
- 25 the requirements of this act with regard to the collection and
- 26 expenditure of fees authorized under this section. A copy of this
- 27 audit shall be transmitted to the legislature upon completion.
