HOUSE BILL No. 5500

March 22, 2016, Introduced by Reps. Tedder and Kesto and referred to the Committee on Judiciary.

A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

by amending sections 42 and 726c (MCL 257.42 and 257.726c), as amended by 2012 PA 529.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 42. "Police officer" means any of the following:
- 2 (a) A sheriff or sheriff's deputy.
 - (b) A village or township marshal.
 - (c) An officer of the police department of any city, village, or township.
 - (d) An officer of the Michigan state police.
 - (e) A peace officer who is trained and **LICENSED OR** certified under the **MICHIGAN** commission on law enforcement standards act,
