HOUSE SUBSTITUTE FOR SENATE BILL NO. 796

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 11 and 17b (MCL 388.1611 and 388.1617b),
section 11 as amended by 2015 PA 139 and section 17b as amended by
2007 PA 137.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) For the fiscal year ending September 30, 2015,
- 2 there is appropriated for the public schools of this state and
- 3 certain other state purposes relating to education the sum of
- 4 \$11,814,097,400.00 from the state school aid fund, the sum of
- 5 \$18,000,000.00 from the MPSERS retirement obligation reform reserve
- 6 fund created under section 147b, and the sum of \$33,700,000.00 from
- 7 the general fund. For the fiscal year ending September 30, 2016,
- 8 2017, there is appropriated for the public schools of this state

- 1 and certain other state purposes relating to education the sum of
- $$^{\$12,078,985,100.00}$$ \$0.00 from the state school aid fund and the sum
- 3 of \$45,900,000.00 \$0.00 from the general fund. In addition, all
- 4 other available federal funds are appropriated each fiscal year for
- 5 the fiscal years YEAR ending September 30, 2015 and September 30,
- $6 \frac{2016.2017.}{}$
- 7 (2) The appropriations under this section shall be allocated
- 8 as provided in this article. Money appropriated under this section
- 9 from the general fund shall be expended to fund the purposes of
- 10 this article before the expenditure of money appropriated under
- 11 this section from the state school aid fund.
- 12 (3) Any general fund allocations under this article that are
- 13 not expended by the end of the state fiscal year are transferred to
- 14 the school aid stabilization fund created under section 11a.
- 15 Sec. 17b. (1) Not later than October 20, November 20, December
- 16 20, January 20, February 20, March 20, April 20, May 20, June 20,
- 17 July 20, and August 20, the department shall prepare electronic
- 18 files of the amount to be distributed under this act in the
- 19 installment to the districts and intermediate districts and deliver
- 20 the electronic files to the state treasurer, and the state
- 21 treasurer shall pay the installments on each of those dates or, if
- 22 the date is not a business day, on the next business day following
- 23 that date. Except as otherwise provided in this act, the portion of
- 24 the district's or intermediate district's state fiscal year
- 25 entitlement to be included in each installment shall be 1/11. A
- 26 district or intermediate district shall accrue the payments

- 7 intermediate district, or if the state treasurer receives a written
- 8 request by the treasurer of the district or intermediate district
- 9 specifying an account, by electronic funds transfer to that account
- 10 of the amount payable to the district or intermediate district
- 11 according to the electronic files. The department may make
- 12 adjustments in payments made under this section through additional
- 13 payments when changes in law or errors in computation cause the
- 14 regularly scheduled payment to be less than the amount to which the
- 15 district or intermediate district is entitled pursuant to this act.
- 16 (3) Except as otherwise provided in this act, grant payments
- 17 to districts and intermediate districts under this act shall be
- 18 paid according to the installment PAYMENT schedule under subsection
- **19** (1).
- 20 (4) Upon the written request of a district or intermediate
- 21 district and the submission of proof satisfactory to the department
- 22 of a need of a temporary and nonrecurring nature, the
- 23 superintendent, with the written concurrence of the state treasurer
- 24 and the state budget director, may authorize an advance release of
- 25 funds due a district or intermediate district under this act. An
- 26 advance authorized under this subsection shall not cause funds to
- 27 be paid to a district or intermediate district more than 30 days

1 earlier than the established payment date for those funds.
