

# HOUSE BILL No. 5565

April 14, 2016, Introduced by Reps. Moss, Wittenberg, Greig, Plawecki, Chang, Guerra, Kelly, Schor, Faris, Sarah Roberts, Irwin, Robinson, Gay-Dagnogo, Byrd, Banks, Hoadley, Pagan, Zemke and LaGrand and referred to the Committee on Government Operations.

A bill to amend 2013 PA 240, entitled "Michigan state capitol historic site act," by amending section 6 (MCL 4.1946).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 6. (1) The commission shall do all of the following:

2           (a) Subject to ~~subsection~~ **SUBSECTIONS (2) AND (3)**, operate and  
3 manage the Michigan ~~state capitol historic site~~. **STATE CAPITOL**  
4 **HISTORIC SITE.**

5           (b) Maintain and restore the ~~state capitol building~~. **STATE**  
6 **CAPITOL BUILDING.**

7           (c) Maintain and improve the grounds of the Michigan ~~state~~  
8 ~~capitol historic site~~. **STATE CAPITOL HISTORIC SITE.**

9           (d) Appoint an individual to manage the day-to-day operations  
10 of the Michigan ~~state capitol historic site~~. **STATE CAPITOL HISTORIC**

1 **SITE.** The individual appointed under this subdivision is an at-will  
2 employee and shall serve at the pleasure of the commission.

3 (e) Employ staff to carry out the commission's  
4 responsibilities under **THIS** subsection ~~(1)~~ and as otherwise  
5 provided by law. All individuals employed by the commission are  
6 nontenured, at-will employees. The commission may discipline,  
7 transfer, demote, suspend, or summarily discharge an employee.

8 (f) Contract with any person for purposes of procuring goods  
9 or services or otherwise carrying out the commission's  
10 responsibilities with regard to the Michigan ~~state capitol historic~~  
11 ~~site.~~ **STATE CAPITOL HISTORIC SITE.**

12 (g) Make recommendations to the governor, the senate, and the  
13 house of representatives regarding funding for the Michigan ~~state~~  
14 ~~capitol historic site,~~ **STATE CAPITOL HISTORIC SITE,** including, but  
15 not limited to, funding from the fund.

16 (h) Carry out other responsibilities as provided by law.

17 **(2) THE COMMISSION SHALL NOT PROHIBIT AN INDIVIDUAL FROM**  
18 **BRINGING A SIGN ONTO THE GROUNDS OF THE MICHIGAN STATE CAPITOL**  
19 **HISTORIC SITE OR INTO THE STATE CAPITOL BUILDING.**

20 **(3) ~~(2)~~**The commission does not have authority and shall not  
21 exercise control over the internal decisions of the senate or the  
22 house of representatives related to the allocation of space in the  
23 ~~state capitol building~~ **STATE CAPITOL BUILDING** or the ~~state capitol~~  
24 ~~building parking lot,~~ **STATE CAPITOL BUILDING PARKING LOT,** including  
25 legislative or staff offices. All decisions concerning space in the  
26 ~~state capitol building~~ **STATE CAPITOL BUILDING** and the ~~state capitol~~  
27 ~~building parking lot~~ **STATE CAPITOL BUILDING PARKING LOT** shall be

- 1 made according to the rules or practices of the senate and the
- 2 house of representatives.
