May 12, 2016, Introduced by Rep. Lucido and referred to the Committee on Regulatory Reform.

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2677) by adding section 728a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 728A. (1) A FIRM ENGAGED IN THE PRACTICE OF PUBLIC
- 2 ACCOUNTING IN THIS STATE SHALL NOT PERFORM ATTEST OR COMPILATION
- 3 SERVICES FOR PUBLIC BODIES UNLESS IT MEETS ALL OF THE FOLLOWING:
- 4 (A) HOLDS A MICHIGAN LICENSE UNDER THIS PART.
- 5 (B) PROVIDES A SURETY BOND TO THE DEPARTMENT THAT MEETS ALL OF 6 THE FOLLOWING:
  - (i) IS ISSUED BY A BONDING COMPANY OR INSURANCE COMPANY AUTHORIZED TO DO BUSINESS IN THIS STATE.
    - (ii) EXPIRES AFTER THE DATE THE FIRM'S LICENSE EXPIRES.
    - (iii) IS IN A PRINCIPAL AMOUNT OF AT LEAST \$25,000,000.00, AS

- 2 (iv) IS IN A FORM SATISFACTORY TO THE DEPARTMENT, IS PAYABLE

- 4 SECURES THE PERFORMANCE OF THE OBLIGATIONS OF THE APPLICANT IN
