## **HOUSE BILL No. 5670**

May 19, 2016, Introduced by Rep. Kosowski and referred to the Committee on Criminal Justice.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 141b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 141B. (1) A PERSON WHO INFLICTS CRUEL TREATMENT ON A
- 2 COMPANION ANIMAL IN THE PRESENCE OF A CHILD IS GUILTY OF A
- 3 MISDEMEANOR PUNISHABLE BY A FINE OF \$500.00 AND NOT LESS THAN 100
- 4 HOURS OF COMMUNITY SERVICE. THIS SUBSECTION APPLIES WHETHER OR NOT
- 5 THE PERSON IS CHARGED WITH OR CONVICTED OF A VIOLATION OF THIS
- 6 CHAPTER FOR THE MISTREATMENT OF THE COMPANION ANIMAL.
- 7 (2) A CHARGE AND CONVICTION UNDER THIS SECTION DO NOT PROHIBIT
- 8 A PERSON FROM BEING CHARGED WITH, CONVICTED OF, OR SENTENCED FOR
  - ANY OTHER VIOLATION OF LAW ARISING OUT OF THE SAME TRANSACTION AS

- 2 (3) AS USED IN THIS SECTION:
- 3 (A) "CHILD" MEANS AN INDIVIDUAL FEWER THAN 18 YEARS OF AGE.
- 4 (B) "COMPANION ANIMAL" MEANS AN ANIMAL THAT IS COMMONLY
- 5 CONSIDERED TO BE, OR IS CONSIDERED BY ITS OWNER TO BE, A PET.
- 6 COMPANION ANIMAL INCLUDES, BUT IS NOT LIMITED TO, CANINES AND
- 7 FELINES.
- 8 (C) "CRUEL TREATMENT" MEANS CONDUCT THAT IS PROHIBITED, OR
- 9 THAT IS SUBSTANTIALLY SIMILAR TO CONDUCT PROHIBITED, UNDER 1 OR
- 10 MORE OF THE FOLLOWING:
- 11 (i) SECTION 49, INVOLVING DOG FIGHTING OR DOG BAITING.
- 12 (ii) SECTION 50, INVOLVING NEGLECT OR A FAILURE TO PROVIDE
- 13 ADEQUATE CARE.
- 14 (iii) SECTION 50B, INVOLVING KILLING, TORTURING, MUTILATING,
- 15 MAIMING, OR DISFIGURING AN ANIMAL.
- 16 (iv) SECTION 158, INVOLVING A CRIME AGAINST NATURE WITH AN
- 17 ANIMAL.
- 18 Enacting section 1. This amendatory act takes effect 90 days
- 19 after the date it is enacted into law.
