

# HOUSE BILL No. 5955

October 19, 2016, Introduced by Rep. Hughes and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16g of chapter XVII (MCL 777.16g), as amended  
by 2012 PA 195.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

### 1 CHAPTER XVII

2 Sec. 16g. (1) This chapter applies to the following felonies  
3 enumerated in chapter 750 of the Michigan Compiled Laws:

7           (2) For a violation of section 145d of the Michigan penal  
8 code, 1931 PA 328, MCL 750.145d, determine the offense category,  
9 offense variable level, and prior record variable level based on  
10 the underlying offense.

11           Enacting section 1. This amendatory act takes effect 90 days  
12 after the date it is enacted into law.

13           Enacting section 2. This amendatory act does not take effect  
14 unless Senate Bill No. \_\_\_\_ or House Bill No. 5954 (request no.  
15 05354'16) of the 98th Legislature is enacted into law.
