May 19, 2016, Introduced by Senator CASPERSON and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 312j.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 312J. (1) THE DEPARTMENT SHALL ESTABLISH A PILOT PROGRAM
- 2 THAT, AS DETERMINED BY THE DEPARTMENT, PROVIDES FOR THE VEHICLE
- 3 GROUP DESIGNATION TESTING OF AN INDIVIDUAL WHO IS THE HOLDER OF A
- 4 VALID COMMERCIAL LICENSE PERMIT ISSUED BY A STATE OTHER THAN THIS
- 5 STATE.
- 6 (2) AN INDIVIDUAL WHO IS THE HOLDER OF A VALID COMMERCIAL
- 7 LICENSE PERMIT ISSUED BY A STATE OTHER THAN THIS STATE IS NOT
- 8 ELIGIBLE FOR VEHICLE GROUP DESIGNATION TESTING IN THIS STATE AS
- 9 DESCRIBED IN SUBSECTION (1) UNLESS ALL OF THE FOLLOWING ARE
- 10 SATISFIED:
 - (A) THE INDIVIDUAL HAS SUCCESSFULLY COMPLETED A TRUCK DRIVER

- 11 LICENSE CURRICULUM REQUIREMENTS FOR A PERSON PROVIDING EDUCATION TO
- 12 INDIVIDUALS SEEKING TO OBTAIN A VEHICLE GROUP DESIGNATION DESCRIBED
- 13 IN SECTION 312E TO QUALIFY TO PROVIDE THE TESTING REQUIRED FOR
- 14 THOSE INDIVIDUALS UNDER SECTION 309.
- 15 Enacting section 1. This amendatory act takes effect 90 days
- 16 after the date it is enacted into law.
