

SENATE SUBSTITUTE FOR  
HOUSE BILL NO. 4668

A bill to amend 1998 PA 58, entitled  
"Michigan liquor control code of 1998,"  
by amending section 221 (MCL 436.1221), as amended by 2018 PA 155,  
and by adding section 914b.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 221. (1) The commission ~~may~~**SHALL** maintain a revolving  
2 fund ~~that is to be~~ derived from the money deposited to the credit  
3 of the commission with the state treasurer. ~~From time to time,~~  
4 ~~money must be transferred~~**MONEY** from the revolving fund **SHALL BE**  
5 **PERIODICALLY TRANSFERRED** to the general fund in accordance with the  
6 management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594. The  
7 **REVOLVING** fund ~~provided for in this section~~ must be used for  
8 replenishing, maintaining, warehousing, and distributing liquor  
9 stock throughout this state and for administration of this act. The

1 commission shall ~~make~~ **PREPARE AND SUBMIT** a monthly report  
2 **CONTAINING AN ACCOUNTING** of the revolving fund to the state  
3 treasurer and to the budget director. The **MONTHLY** report must  
4 include an itemized account of all money received and all  
5 expenditures made by the commission during the month covered in the  
6 report.

7 (2) Interest earnings on common cash attributable to the  
8 revolving fund must be credited to the revolving fund and must be  
9 available to the commission for administration of this act.

10 (3) All money received by the commission under this act must  
11 be turned over to the state treasurer according to department of  
12 treasury procedures.

13 (4) All money deposited by the commission with the state  
14 treasurer must be credited to the revolving fund for expenditures  
15 or transfers authorized under subsection (1).

16 (5) **AS USED IN THIS SECTION, "REVOLVING FUND" MEANS THE**  
17 **REVOLVING FUND ESTABLISHED UNDER SUBSECTION (1).**

18 **SEC. 914B. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (2),**  
19 **A PERSON SHALL NOT USE OR OFFER FOR USE, POSSESS, SELL, OR OFFER**  
20 **FOR SALE MARIHUANA-INFUSED BEER, WINE, MIXED WINE DRINK, MIXED**  
21 **SPIRIT DRINK, OR SPIRITS. A PERSON THAT VIOLATES THIS SECTION IS**  
22 **GUILTY OF A MISDEMEANOR PUNISHABLE AS PROVIDED IN SECTION 909.**

23 (2) **THIS SECTION DOES NOT APPLY TO A HOSPITAL THAT OPERATES**  
24 **PRIMARILY FOR THE PURPOSE OF CONDUCTING SCIENTIFIC RESEARCH, A**  
25 **STATE INSTITUTION CONDUCTING BONA FIDE RESEARCH, A PRIVATE COLLEGE**  
26 **OR UNIVERSITY CONDUCTING BONA FIDE RESEARCH, OR A PHARMACEUTICAL**  
27 **COMPANY OR BIOTECHNOLOGY COMPANY CONDUCTING BONA FIDE RESEARCH.**

1 (3) AS USED IN THIS SECTION:

2 (A) "MARIHUANA" MEANS THAT TERM AS DEFINED IN SECTION 7106 OF  
3 THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.7106.

4 (B) "MARIHUANA-INFUSED BEER, WINE, MIXED WINE DRINK, MIXED  
5 SPIRIT DRINK, OR SPIRITS" MEANS BEER, WINE, MIXED WINE DRINK, MIXED  
6 SPIRIT DRINK, OR SPIRITS THAT CONTAIN ANY AMOUNT OF MARIHUANA.
