

# HOUSE BILL No. 6199

June 12, 2018, Introduced by Reps. Cole, Allor, LaFave, Hughes, Alexander, Hornberger, Kahle and Barrett and referred to the Committee on Michigan Competitiveness.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 13g of chapter XVII (MCL 777.13g), as amended by 2014 PA 403.
