A bill to amend 1976 PA 399, entitled "Safe drinking water act," by amending section 3 (MCL 325.1003).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 3. (1) Subject to SUBSECTION (2) AND THE limitations 2 contained in this act, the department shall have HAS power and 3 control over public water supplies and suppliers of water. The director may enter upon the waterworks system of a supplier of 5 water at reasonable times for the purpose of inspecting the WATERWORKS system and carrying out this act and rules promulgated under this act.

- 14 ENFORCEMENT ACTION.
- 15 (ii) REQUEST THE ATTORNEY GENERAL TO COMMENCE AN ACTION IN
- 16 COURT TO ENFORCE THIS ACT.
