November 27, 2018, Introduced by Rep. Noble and referred to the Committee on Law and Justice.

A bill to amend 1927 PA 175, entitled
 "The code of criminal procedure,"
 by amending section 14a of chapter XVII (MCL 777.14a), as amended
 by 2010 PA 378.
