

# SENATE BILL No. 391

May 18, 2017, Introduced by Senators CASPERSON, HILDENBRAND, COLBECK, BOOHER, GREEN, PAVLOV, ROBERTSON, PROOS, HANSEN, HORN, JONES, MARLEAU, NOFS, KOWALL, STAMAS, SCHUITMAKER, KNOLLENBERG, O'BRIEN, EMMONS, SCHMIDT and SHIRKEY and referred to the Committee on Health Policy.

A bill to amend 1927 PA 175, entitled  
 "The code of criminal procedure,"  
 by amending section 16d of chapter XVII (MCL 777.16d), as amended  
 by 2016 PA 88.

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies
