House Joint Resolution R

Senator Kowall moved that rule 3.902 be suspended to allow the guests of Senators Proos and Schuitmaker admittance to the Senate floor.

The motion prevailed, a majority of the members serving voting therefor.

Senators Green, Hildenbrand, Zorn and Brandenburg entered the Senate Chamber.

Senators Proos and Schuitmaker asked and were granted unanimous consent to make statements and moved that the statements be printed in the Journal.

The motion prevailed.

Senator Proos' first statement is as follows:

It is a great honor for me to be joined by my colleagues, Senator Tonya Schuitmaker and Senator Mike Nofs, for a very special presentation before the Senate today, and before the entire state of Michigan, to say "thank you" and to honor some good Samaritans who went out of their way to save a trooper's life. Let that sink in for just a moment if you could. Two good Samaritans put themselves in harm's way to save a trooper's life. One of our finest. One of those who is entrusted with the safety and security of the state of Michigan as a Michigan State Police Trooper.

Today we honor Jerry Burnham and Keith Pepple. We're joined by their families also. Jerry is with his wife, Lisa, and children, Jordan and Nikki Burnham. We also have Senator Schuitmaker's constituent, Keith Pepple, and his family. Senator Schuitmaker will introduce them. In addition, we are joined by Trooper Garry Guild, who was the trooper involved in the incident that was intervened in at the time of crisis. We will give some more details to that in a few moments. With him also is Captain Mike Brown, the 5th District Commander, and Lieutenant Michael Dawson, the Post Commander out of Niles where Trooper Guild is stationed.

Senator Schuitmaker's statement is as follows:

Our State Police do so much to protect our lives, so it's unfortunate when things don't go as planned, but luckily on this day there were two good Samaritans. My good Samaritan, Keith Pepple is joined by his family—his wife, Heather, son, Nick, and daughter, Ashley. They have to be so proud of their husband and father. We thank him for his quick actions that helped save a trooper in what could have been a very unfortunate event. We thank all of the police officers who put their lives on the line each and every day.

Senator Proos' second statement is as follows:

You may have seen the video of the chase that has gone viral from the dash cam of Trooper Guild. Unfortunately, the chase ended up with him in conflict with the offender. The offender was able to get Trooper Guild into a position of submission that was very dangerous. At that exact moment, these two good Samaritans happened to pull over on a freeway. All of us have been on a freeway where we have seen something happen and had to make that split second decision. Neither of these two hesitated. Instead they got out of their vehicles and put themselves at risk to save Trooper Guild.

On February 20, Michigan State Trooper Garry Guild was in pursuit of a fleeing motorcyclist which resulted in two men attacking the trooper on the side of the road, as others also engaged on behalf of the offender. The ensuing pursuit on the motorcycle resulted in the altercation where both men witnessed the motorcyclist and another individual attacking Trooper Guild. Without hesitation, both Jerry and Keith stopped their vehicles and came to the aid of Trooper Guild. Their quick response to this attack prevented Trooper Guild from being choked unconscious and from further harm that could have followed.

Due to the bravery of these two individuals, the attackers were apprehended, and more importantly, the life of Trooper Guild was saved. It is evident that it doesn't just happen that two individuals like Jerry and Keith would stop their vehicles to engage. It is important that all of us in the Senate and throughout the state, stop and say "thank you," and remember that we hold each other's lives in our hands. It is up to us to engage when asked and called upon. We applaud each of them for their honorable display of courage and we sincerely thank them for saving the life of a trooper, and ultimately ensuring the safety and security of the state of Michigan.

We each have prepared Special Tributes that give details of the incident, but also give the honor of signatures from Lieutenant Governor Calley, Governor Rick Snyder, our Congressman Fred Upton in the 6th District, Representative Pagel, and myself and Senator Schuitmaker. Please help me thank Jerry Burnham and Keith Pepple for their heroic and honorable actions that saved Trooper Guild's life that day.
