A bill to amend 1979 PA 152, entitled  
"State license fee act,"  
by amending section 43 (MCL 338.2243), as amended by 2019 PA 71.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 43. Fees for a person licensed or seeking licensure to  
2 engage in the practice of mortuary science or to operate a funeral  
3 establishment or for a person licensed or seeking licensure as a  
4 resident trainee or licensed as an embalmer or funeral director  
5 under article 18 of the occupational code, MCL 339.1801 to
