

HOUSE BILL NO. 4131

February 06, 2019, Introduced by Reps. Griffin, Tyrone Carter, Bolden and Filler and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
(MCL 750.1 to 750.568) by adding section 197d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 197d. (1) A person who does any of the following is
2 guilty of a misdemeanor punishable by imprisonment for not more
3 than 1 year or a fine of not more than \$1,000.00, or both:

4 (a) Sells, gives, or furnishes, either directly or indirectly,
5 poison, a controlled substance, or a weapon to a medically frail
6 parolee knowing that person is a medically frail parolee. This

1 subdivision does not apply to a person who provides a controlled
2 substance to a medically frail parolee if that controlled substance
3 has been prescribed by a physician for use by a medically frail
4 parolee.

5 (b) With the intent to assist a medically frail parolee
6 abscond from parole, assist a medically frail parolee in leaving or
7 attempting to leave a medical facility in which the medically frail
8 parolee has been placed as a condition of his or her medically
9 frail parole.

10 (c) Knowingly cause a medically frail parolee to have contact
11 with a person with whom the medically frail parolee is prohibited
12 from having contact as a condition of his or her medically frail
13 parole or a valid personal protection order.

14 (2) This section does not apply to a person who aids or
15 assists a medically frail parolee in leaving or attempting to leave
16 a medical facility in which the medically frail parolee has been
17 placed as a condition of his or her medically frail parole because
18 of any of the following:

19 (a) The medically frail parolee requires a medical service
20 that must be performed at a different medical facility.

21 (b) The medically frail parolee has a medical emergency that
22 requires medical service at a different medical facility.

23 (c) There is a natural disaster, fire, or infrastructural
24 failure at the medical facility in which the medically frail
25 parolee has been placed that necessitates evacuating the medically
26 frail parolee.

27 (3) As used in this section:

28 (a) "Controlled substance" means that term as defined in
29 section 7104 of the public health code, 1978 PA 368, MCL 333.7104.

1 (b) "Medical facility" means a hospital, hospice, nursing
2 home, or other housing accommodation providing medical treatment
3 suitable to the condition or conditions rendering the parolee
4 medically frail.

5 (c) "Medically frail parole" means a parole granted under
6 section 35(10) of the corrections code of 1953, 1953 PA 232, MCL
7 791.235.

8 (d) "Medically frail parolee" means an individual granted
9 parole under section 35(10) of the corrections code of 1953, 1953
10 PA 232, MCL 791.235.

11 Enacting section 1. This amendatory act takes effect 90 days
12 after the date it is enacted into law.

13 Enacting section 2. This amendatory act does not take effect
14 unless Senate Bill No.____ or House Bill No.____ (request no.
15 01446'19) of the 100th Legislature is enacted into law.
