16 (2) Except as otherwise provided by an administrative rule in
17 effect on October 1, 1988, or as otherwise provided by law, a
18 certificate, permit, authorization, endorsement, or approval, and
19 the renewal of a certificate, certificate reinstatement, or
20 authorization issued pursuant to ~~under~~ subsection (1) is valid for
21 5 years.

22 (3) A veteran or a military spouse may request a waiver for
23 any of the fees listed under subsection (1) from the department in
24 a form and manner prescribed by the department. Upon receipt of a
25 request for a waiver submitted by a veteran or a military spouse
26 under this subsection, the department shall grant the request for a
27 waiver and shall waive 100% of the fee for which the veteran or the
28 military spouse requested a waiver.

29 (4) As used in this section:



1 (a) "Active duty" means full-time duty in the United States
2 Armed Forces, including the reserve components.

3 (b) "Military spouse" means the spouse of an active duty
4 member of the United States Armed Forces, including the reserve
5 components.

6 (c) "Veteran" means that term as defined in section 1 of 1965
7 PA 190, MCL 35.61.
