SENATE RESOLUTION NO.71

Senators Schmidt and Daley offered the following resolution:

- 1 A resolution to support the U.S. cherry industry's petition
- 2 before the U.S. International Trade Commission stating unfair trade
- 3 practices against Turkey and to urge the Commission and the U.S.
- 4 Department of Commerce to take action protecting U.S. cherry
- 5 farmers.
- 6 Whereas, Michigan is the primary tart cherry producing state,
- 7 growing 189 million pounds in 2017, or nearly 75% of the nation's
- 8 crop. Tart cherry production in the United States totaled 259.5
- 9 million pounds in 2017, valued at \$56.8 million; and
- 10 Whereas, Turkish imports have caused tart cherry prices to
- 11 crash, significantly damaging Michigan's industry. The amount of
- 12 dried cherries imported from Turkey have grown exponentially over
- 13 the last three years, more than tripling from 2016 to 2018.

- 2 cents per pound while the U.S. product sells for an average of
- **3** \$4.60 per pound; and
- 4 Whereas, On April 23, 2019, the Dried Tart Cherry Trade
- 5 Committee filed petitions with the U.S. International Trade
- 6 Commission and the U.S. Department of Commerce, claiming that
- 7 Turkey is flooding the U.S. market with dried tart cherries,
- 8 lowering domestic product prices and causing material injury to
- 9 tart cherry producers in Michigan and other cherry growing states;
- **10** and
- 11 Whereas, In June, the U.S. International Trade Commission
- 12 issued a preliminary ruling that Turkish imports "had a significant
- 13 adverse impact on the domestic industry." A final ruling is
- 14 expected early next year. If Turkish imports are determined to be
- 15 injurious to the U.S. market, the Department of Commerce will
- 16 determine the duties to be imposed; and
- 17 Whereas, If the industry loses its case, few cherry growers
- 18 will survive. Already trees are being destroyed as it costs more
- 19 to harvest fruit than the current return on the product. Jobs will
- 20 be lost both in seasonal workers in the field and the thousands of
- 21 employees in processing plants who work year-round preparing
- 22 cherries for market; now, therefore, be it
- 23 Resolved by the Senate, That we support the U.S. cherry
- 24 industry's petition before the U.S. International Trade Commission
- 25 stating unfair trade practices against Turkey and urge the
- 26 Commission and the U.S. Department of Commerce to take action
- 27 protecting U.S. cherry farmers; and be it further
- 28 Resolved, That copies of this resolution be transmitted to the
- 29 members of the U.S. International Trade Commission, the United

- 1 States Secretary of Commerce, and the members of the Michigan
- 2 congressional delegation.
