SUMMARY:

House Bill 4346 would amend the Insurance Code to require an insurer that delivers, issues for delivery, or renews a health insurance policy that provides coverage for prescription insulin drugs to cap the total amount the insured person is required to pay for the insulin drugs at \$50 for each 30-day supply.

This provision would not prevent an insurer from reducing the insured person's cost sharing by an amount greater than \$50.

The bill states that this provision would apply to health insurance policies delivered, executed, issued, amended, adjusted, or renewed in Michigan or covering Michigan residents beginning 90 days after the date the bill is enacted.
