## PROVISIONS CONCERNING APPROPRIATIONS

**GENERAL SECTIONS**

4       Sec. 201. Pursuant to section 30 of article IX of the state  
5 constitution of 1963, total state spending from state sources under  
6 part 1 for the fiscal year ending September 30, 2022 is \$0.00 and  
7 total state spending from state sources to be paid to local units  
8 of government is \$0.00.

9       Sec. 202. The appropriations made and expenditures authorized  
10 under this part and part 1 and the departments, commissions,  
11 boards, offices, and programs for which appropriations are made  
12 under this part and part 1 are subject to the management and budget  
13 act, 1984 PA 431, MCL 18.1101 to 18.1594.

14       Sec. 203. If the state administrative board, acting under  
15 section 3 of 1921 PA 2, MCL 17.3, transfers funds from an amount  
16 appropriated under this act, the legislature may, by a concurrent  
17 resolution adopted by a majority of the members elected to and  
18 serving in each house, inter-transfer funds within this act for the  
19 particular department, board, commission, office, or institution.

20       Sec. 204. Funds appropriated in part 1 are subject to  
21 applicable federal audit and reporting requirements. Prompt action  
22 shall be taken if instances of noncompliance are identified,  
23 including noncompliance identified in an audit finding. If any  
24 instance of noncompliance is identified, including noncompliance  
25 identified in an audit finding, the state budget director shall  
26 take necessary and immediate action to rectify it. The state budget  
27 director shall notify the senate and house appropriations  
28 committees and the senate and house fiscal agencies when an  
29 instance of noncompliance is identified.

1           Sec. 205. Funds appropriated in part 1 from the federal  
2 American rescue plan act of 2021, Public Law 117-2, must be  
3 allocated and expended in a manner consistent with federal rules  
4 and regulations.

5           Sec. 206. The state budget director shall report on the status  
6 of funds appropriated in part 1, and all funds appropriated related  
7 to the coronavirus relief effort, to the senate and house  
8 appropriations committees and the senate and house fiscal agencies  
9 on a monthly basis until all funds are exhausted.

10

11 **CAPITAL OUTLAY**

12           Sec. 226. (1) The funds appropriated in part 1 for the new  
13 comprehensive state public health and environmental science  
14 laboratory shall be used for the planning and design of a  
15 consolidated, comprehensive, state-of-the-art laboratory to improve  
16 laboratory capacity for public health and safety.

17           (2) The department shall submit all of the following to the  
18 house and senate appropriations committees and the joint capital  
19 outlay subcommittee:

20           (a) Program statements and schematic planning documents,  
21 including a comparative assessment of building new laboratories,  
22 expanding existing laboratories, renovating existing laboratories,  
23 or repurposing another state-owned building.

24           (b) A summary of bid results.

25           (c) A progress report no later than June 1, 2022 and every 6  
26 months thereafter.

27 **DEPARTMENT OF EDUCATION**

28           Sec. 251. (1) From the funds appropriated in part 1 for ARP -

29

1 work-based learning health services academies, the department of  
2 education shall allocate \$250,000.00 as competitive grants to  
3 school districts and intermediate school districts that provide  
4 pupils in grades 9 through 12 with expanded opportunities for work-  
5 based learning health services academies hosted in partnership with  
6 NAF. Programs funded under this subsection are intended to increase  
7 the number of pupils who are college- and career-ready after high  
8 school graduation.

9 (2) To be eligible for a competitive grant funded under this  
10 section, the school district or intermediate school district must  
11 demonstrate that it has established a partnership with NAF, has at  
12 least 1 business entity on its advisory council, and has a higher  
13 education institution or technical school on its advisory council,  
14 and submit a spending plan.

15 (3) The department of education shall prioritize competitive  
16 grant awards under this section that target critical-need  
17 occupations.

18 (4) The department of education may award planning grants not  
19 to exceed \$12,000.00 and expense grants for NAF partnerships not to  
20 exceed \$3,500.00 a year.

21 (5) The unexpended funds appropriated in part 1 for ARP -  
22 work-based learning health services academies are designated as a  
23 work project appropriation, and any unencumbered or unallotted  
24 funds shall not lapse at the end of the fiscal year and shall be  
25 available for expenditures for projects under this section until  
26 the projects have been completed. The following is in compliance  
27 with section 451a of the management and budget act, 1984 PA 431,  
28 MCL 18.1451a:

29 (a) The purpose of the project is to support work-based



1 learning health services academies in partnership with NAF.

2 (b) The project will be accomplished by utilizing competitive  
3 grants.

4 (c) The total estimated cost of the project is \$250,000.00.

5 (d) The tentative completion date is September 30, 2023.

**DEPARTMENT OF HEALTH AND HUMAN SERVICES**

8 Sec. 301. (1) The funds appropriated in part 1 for ARP -  
9 cooperative agreement for emergency response must be allocated by  
10 the department to local and tribal public health departments,  
11 school districts, public school academies, intermediate school  
12 districts, and nonpublic schools.

13 (2) Of the funds appropriated in part 1, no less than  
14 \$14,900,000.000 shall be appropriated to school districts, public  
15 school academies, intermediate school districts, and nonpublic  
16 schools to administer and support coronavirus testing of staff and  
17 students, including, but not limited to, teachers, counselors,  
18 administrators, support staff, aides, bus drivers, coaches,  
19 cafeteria staff, custodians, students playing contact sports, and  
20 other students as determined by the eligible school district,  
21 public school academy, intermediate school district, or nonpublic  
22 school.

23 (3) The department shall not allocate funds in this section to  
24 local public health departments for which a county board of  
25 commissioners has passed a resolution rejecting these funds, if the  
26 rejection of these funds has occurred within 30 days of the  
27 effective date of this act.

28 (4) The unexpended funds appropriated in part 1 for ARP -  
29 cooperative agreement for emergency response are designated as a

1 work project appropriation, and any unencumbered or unallotted  
2 funds shall not lapse at the end of the fiscal year and shall be  
3 available for expenditures for projects under this section until  
4 the projects have been completed. The following is in compliance  
5 with section 451a of the management and budget act, 1984 PA 431,  
6 MCL 18.1451a:

7 (a) The purpose of the project is to conduct activities  
8 necessary to support the efforts of schools and local and tribal  
9 public health officials with respect to coronavirus testing,  
10 contact tracing, vaccine distribution efforts, and the  
11 administration of COVID-19 mitigation efforts.

12 (b) The project will be accomplished by utilizing state  
13 employees or contracts.

14 (c) The total estimated cost of the project is \$29,704,700.

15 (d) The tentative completion date is September 30, 2026.

16 Sec. 302. (1) From the funds appropriated in part 1 for FEMA -  
17 COVID-19 early treatment and testing sites, the department of  
18 health and human services shall allocate \$75,000,000.00 to  
19 establish not less than 1 COVID-19 early treatment and testing site  
20 within each of this state's 8 emergency preparedness regions.

21 (2) An eligible COVID-19 early treatment and testing site may  
22 be a local department of health and human services office, a local  
23 public health department office, or a local health care provider.

24 (3) Not less than \$10,000,000.00 of the funds appropriated  
25 pursuant to this section must be allocated to local health care  
26 providers.

27 (4) An eligible COVID-19 early treatment and testing site must  
28 do all of the following:

29 (a) Maximize the number of COVID-19 therapeutic treatments

1 that can be administered and minimize the time period between known  
2 infection and actual administering of the treatment.

3 (b) Utilize eligibility and prioritization criteria for COVID-  
4 19 therapeutic treatments that are not more stringent than federal  
5 eligibility and prioritization criteria for COVID-19 therapeutic  
6 treatments.

7 (c) Prioritize COVID-19 therapeutic treatments for high-risk  
8 individuals.

9 (d) Not use an individual's vaccination status as a factor for  
10 denying eligibility for COVID-19 therapeutic treatments.

11 (e) Demonstrate the ability to bill public and private  
12 insurance for the cost to administer COVID-19 therapeutic  
13 treatments.

14 (f) Provide COVID-19 therapeutic treatments at no cost to the  
15 individual.

16 (g) Follow informed consent requirements prior to  
17 administering a COVID-19 therapeutic treatment, as established by  
18 the United States Food and Drug Administration, or described by the  
19 emergency use authorization, or both, including providing all of  
20 the following:

21 (i) Information on alternatives to receiving a COVID-19  
22 therapeutic treatment.

23 (ii) Information on whether the COVID-19 therapeutic treatment  
24 has received full or emergency use authorization from the United  
25 States Food and Drug Administration.

26 (iii) Information on and in what manner the development of the  
27 COVID-19 therapeutic treatment utilized aborted fetal tissue or  
28 human embryonic stem cell derivation lines.

29 (iv) Age-appropriate communications.

1 (5) An eligible COVID-19 early treatment and testing site may  
2 use funds allocated in this section for facility upgrade and  
3 conversion costs, lease and rent costs, staffing costs, personal  
4 protection equipment costs, and any other costs associated with  
5 providing a COVID-19 therapeutic treatment that is not covered by  
6 public or private insurance of the individual that receives the  
7 COVID-19 therapeutic treatment.

8 (6) The department of health and human services may set aside  
9 not more than 10% of the funds allocated in this section to  
10 reimburse eligible COVID-19 treatment sites for the cost of  
11 administering COVID-19 therapeutic treatments to individuals  
12 without public or private health insurance.

13 (7) As other early treatments for COVID-19 are authorized by  
14 the United States Food and Drug Administration, eligible COVID-19  
15 early treatment and testing sites may also administer those early  
16 treatments, provided that the eligible COVID-19 early treatment and  
17 testing sites continue to follow the requirements of this section.

18 (8) As other early treatments for COVID-19 are authorized by  
19 the United States Food and Drug Administration, the department of  
20 health and human services may utilize the funds set aside in  
21 subsection (6) to reimburse eligible COVID-19 early treatment and  
22 testing sites for the cost of administering those treatments to  
23 individuals without public or private health insurance.

24 (9) As used in this section:

25 (a) "Local health care provider" includes, but is not limited  
26 to, a hospital, physician's office, pharmacy, infusion center,  
27 blood or plasma donation center, nursing facility, adult day care  
28 facility, and program of all-inclusive care for the elderly  
29 location.

1 (b) "High-risk individuals" means individuals at higher risk  
2 for progression to severe COVID-19, including, but not limited to,  
3 individuals classified as higher risk based on definitions and  
4 findings from the federal Centers for Disease Control and  
5 Prevention.

6 (10) In addition to the funds appropriated in part 1, there is  
7 appropriated an amount not to exceed \$75,000,000.00 in American  
8 Rescue Plan Act - Coronavirus State Fiscal Recovery Funds for  
9 COVID-19 early treatment and testing sites to be used for projects  
10 under this section, subject to both of the following:

11 (a) The amount appropriated under this subsection must not be  
12 spent or otherwise distributed after the Federal Emergency  
13 Management Agency approves a project for COVID-19 early treatment  
14 and testing sites.

15 (b) Money appropriated under this subsection that is spent or  
16 otherwise distributed before the Federal Emergency Management  
17 Agency approves a project for COVID-19 early treatment and testing  
18 sites must be offset with Federal Emergency Management Agency funds  
19 if received during the fiscal year ending September 30, 2022.

20 Sec. 303. (1) From the funds appropriated in part 1 for FEMA -  
21 COVID-19 early treatments procurements, the department of health  
22 and human services shall allocate \$25,000,000.00 to purchase  
23 additional COVID-19 therapeutic treatments in addition to the  
24 supply of federally allocated COVID-19 therapeutic treatments. The  
25 department of health and human services shall distribute the  
26 additional COVID-19 therapeutic treatments to eligible COVID-19  
27 early treatment and testing sites funded in this part and part 1  
28 based on need and utilization.

29 (2) In addition to the funds appropriated under part 1, there

1 is appropriated an amount not to exceed \$25,000,000.00 in American  
2 Rescue Plan Act - Coronavirus State Fiscal Recovery Funds for  
3 COVID-19 early treatments procurements for projects under this  
4 section, subject to both of the following:

5 (a) The amount appropriated under this subsection must not be  
6 spent or otherwise distributed after the Federal Emergency  
7 Management Agency approves a project for COVID-19 early treatments  
8 procurements.

9 (b) Money appropriated under this subsection that is spent or  
10 otherwise distributed before the Federal Emergency Management  
11 Agency approves a project for COVID-19 early treatments  
12 procurements must be offset with Federal Emergency Management  
13 Agency funds if received during the fiscal year ending September  
14 30, 2022.

15 Sec. 304. (1) Funds appropriated in part 1 for ARP -  
16 epidemiology and lab capacity enhancing detection expansion must be  
17 allocated and expended in a manner consistent with federal rules  
18 and regulations.

19 (2) From the funds appropriated in part 1 for ARP -  
20 epidemiology and lab capacity enhancing detection expansion, there  
21 is allocated an amount not to exceed \$75,000,000.00 for COVID-19  
22 early treatment and testing sites for unreimbursed costs from the  
23 Federal Emergency Management Agency subject to both of the  
24 following:

25 (a) The amount allocated under this subsection must not be  
26 spent or otherwise distributed after the Federal Emergency  
27 Management Agency approves a project for COVID-19 early treatment  
28 and testing sites.

29 (b) Money allocated under this subsection that is spent or

1 otherwise distributed before the Federal Emergency Management  
2 Agency approves a project for COVID-19 early treatment and testing  
3 sites must be offset with Federal Emergency Management Agency funds  
4 if received during the fiscal year ending September 30, 2022.

5 (3) The unexpended funds appropriated in part 1 for ARP -  
6 epidemiology and lab capacity enhancing detection expansion are  
7 designated as a work project appropriation, and any unencumbered or  
8 unallotted funds shall not lapse at the end of the fiscal year and  
9 shall be available for expenditures for projects under this section  
10 until the projects have been completed. The following is in  
11 compliance with section 451a of the management and budget act, 1984  
12 PA 431, MCL 18.1451a:

13 (a) The purpose of the project is to continue to monitor,  
14 respond to, and prevent COVID-19 by expanding testing, contact  
15 tracing, disease investigations and surveillance activities.

16 (b) The project will be accomplished by utilizing state  
17 employees or contracts.

18 (c) The total estimated cost of the project is  
19 \$367,327,300.00.

20 (d) The tentative completion date is September 30, 2026.

21 Sec. 305. (1) From the funds appropriated in part 1 for ARP -  
22 epidemiology and lab capacity school safety, the department of  
23 health and human services shall purchase and maintain an inventory  
24 of coronavirus testing and contact tracing supplies and equipment,  
25 including home test kits, to distribute to school districts, public  
26 school academies, intermediate school districts, and nonpublic  
27 schools. The coronavirus testing and contact tracing supplies and  
28 equipment, including home test kits, shall be used for coronavirus  
29 testing and contact tracing staff and students including, but not

1 limited to, teachers, counselors, administrators, support staff,  
2 aides, bus drivers, coaches, cafeteria staff, custodians, students  
3 playing contact sports, and other students as determined by the  
4 eligible school district, public school academy, intermediate  
5 school district, or nonpublic school, regardless of the  
6 individual's vaccination status.

7 (2) Within 15 calendar days of the effective date of this act,  
8 the department of health and human services shall notify school  
9 districts, public school academies, intermediate school districts,  
10 and nonpublic schools of the option to not participate in the  
11 direct distribution of coronavirus testing and contact tracing  
12 supplies and equipment, including home test kits, the method by  
13 which the school district, public school academy, intermediate  
14 school district, or nonpublic school can opt out, and the maximum  
15 amount of direct financial reimbursement that each school district,  
16 public school academy, intermediate school district, or nonpublic  
17 school could receive based on an equitable head count distribution.  
18 If a school district, public school academy, intermediate school  
19 district, or nonpublic school notifies the department of health and  
20 human services and the Michigan Association of Intermediate School  
21 Administrators not more than 10 business days after receiving the  
22 required notification in this subsection from the department of  
23 health and human services that it does not wish to participate in  
24 the direct distribution of coronavirus testing and contact tracing  
25 supplies and equipment, including home test kits, that school  
26 district, public school academy, intermediate school district, or  
27 nonpublic school may request to receive direct financial  
28 reimbursement from the department of health and human services for  
29 coronavirus testing and contact tracing supplies and equipment,



1 including home test kits, purchased directly by that school  
2 district, public school academy, intermediate school district, or  
3 nonpublic school. A school district, public school academy,  
4 intermediate school district, or nonpublic school that opts out as  
5 described in this subsection may purchase coronavirus testing and  
6 contact tracing supplies and equipment, including home test kits,  
7 either directly from the department of health and human services or  
8 from another source. The department of health and human services  
9 must provide direct financial reimbursement within 30 days of  
10 receipt of the request.

11 (3) The department of health and human services must maintain  
12 a publicly accessible online list of acceptable coronavirus testing  
13 and contact tracing supplies and equipment, including home test  
14 kits, that could be purchased with the funds appropriated in this  
15 section.

16 (4) No state or local government entity shall confiscate or  
17 redistribute coronavirus testing and contact tracing supplies and  
18 equipment, including home test kits, from an eligible school  
19 district, public school academy, intermediate school district, or  
20 nonpublic school without first receiving the consent of that  
21 eligible school district, public school academy, intermediate  
22 school district, or nonpublic school.

23 (5) The department of health and human services shall  
24 collaborate with the Michigan Association of Intermediate School  
25 Administrators to establish procedures for the as-needed  
26 redistribution of coronavirus testing and contract tracing supplies  
27 and equipment, including home kits, from school districts, public  
28 school academies, intermediate school districts, and nonpublic  
29 schools. The Michigan Association of Intermediate School

1 Administrators shall coordinate the redistribution of coronavirus  
2 testing and contact tracing supplies and equipment, including home  
3 kits, based on need and after receiving the consent of that school  
4 district, public school academy, intermediate school district, or  
5 nonpublic school. Not more than 1% of the funds appropriated in  
6 part 1 for ARP - epidemiology and lab capacity school safety, or an  
7 amount equal to actual costs incurred, whichever is less, may be  
8 used by the Michigan Association of Intermediate School  
9 Administrators for administrative and logistical costs related to  
10 this subsection.

11 (6) Subsections (4) and (5) do not prohibit an eligible school  
12 district, public school academy, intermediate school district, or  
13 nonpublic school from voluntarily sending coronavirus testing and  
14 contact tracing supplies and equipment, including home test kits,  
15 in its possession to another eligible school district, public  
16 school academy, intermediate school district, or nonpublic school  
17 that is in need of additional coronavirus testing and contact  
18 tracing supplies and equipment, including home test kits.

19 (7) The department of health and human services shall  
20 collaborate with the department of education to effectuate this  
21 section.

22 (8) The unexpended funds appropriated in part 1 for ARP -  
23 epidemiology and lab capacity school safety are designated as a  
24 work project appropriation, and any unencumbered or unallotted  
25 funds shall not lapse at the end of the fiscal year and shall be  
26 available for expenditures for projects under this section until  
27 the projects have been completed. The following is in compliance  
28 with section 451a of the management and budget act, 1984 PA 431,  
29 MCL 18.1451a:

1 (a) The purpose of the project is to support screening and  
2 testing activities to facilitate the safe operations of in-person  
3 school instruction at eligible school districts, public school  
4 academies, intermediate school districts, and nonpublic schools.

5 (b) The project will be accomplished by utilizing state  
6 employees or contracts.

7 (c) The total estimated cost of the project is  
8 \$150,799,300.00.

9 (d) The tentative completion date is September 30, 2026.

10 Sec. 306. (1) From the funds appropriated in part 1 for ARP -  
11 health care recruitment, retention, and training, the department of  
12 health and human services shall allocate \$300,000,000.00 for health  
13 care recruitment, retention, and training programming to health  
14 care employers that can demonstrate an eligible qualifying need  
15 under the rules and regulations of the federal coronavirus state  
16 fiscal recovery funding. Additionally, health care employers must  
17 not request funds under this section for any investments related to  
18 recruitment or retention announced before December 1, 2021.

19 (2) The department of health and human services must allocate  
20 75% of the funds appropriated pursuant to this section to the  
21 Michigan Health and Hospital Association for administration to  
22 acute care and behavioral health care providers, of which not less  
23 than 10% appropriated pursuant to this subsection must be allocated  
24 to critical access hospitals and small and rural providers that are  
25 awarded rural access payments under section 1802(2) of article 6 of  
26 2021 PA 87.

27 (3) The department of health and human services must allocate  
28 25% of the funds appropriated pursuant to this section to post-  
29 acute care providers and federally qualified health centers

1 (FQHCs).

2 (4) If a health care employer receives funds appropriated  
3 pursuant to this section and has established a COVID-19 vaccine  
4 policy, the policy must allow for an employee exemption for both of  
5 the following:

6 (a) Any employee for whom a physician certifies and properly  
7 documents that a COVID-19 vaccine is clinically contraindicated for  
8 the employee.

9 (b) Any employee who provides a written statement and can  
10 document in a manner consistent with the health care employer's  
11 policies and procedures that the requirements of the COVID-19  
12 vaccine policy cannot be met because of the employee's religious  
13 convictions.

14 (5) Health care recruitment, retention, and training  
15 programming may include, but is not limited to, cash recruitment  
16 bonuses, student loan payment assistance, cash retention bonuses,  
17 tuition assistance, and other forms of training programming. The  
18 maximum amount any health care employer, except for critical access  
19 hospitals and small and rural providers that are awarded rural  
20 access payments under section 1802(2) of article 6 of 2021 PA 87,  
21 can use for cash recruitment bonuses is 25%, and the maximum amount  
22 any health care employer, except for critical access hospitals and  
23 small and rural providers that are awarded rural access payments

25 retention bonuses is 20%.

26 (6) Nothing in this section requires a health care employer  
27 that receives funds appropriated in this section to violate any  
28 federal rule or regulation on a COVID-19 vaccine policy.

29 (7) If a health care employer receives funds appropriated in

1 this section and has established a COVID-19 vaccine policy, the  
2 policy must require the employer to respond in a written statement  
3 of an employee's COVID-19 vaccine exemption approval or  
4 disapproval.

5 (8) As a condition of receiving funds appropriated in this  
6 section, a health care employer must agree to not use an employee's  
7 vaccination status as a factor for distributing recruitment,  
8 retention, and training program funds under this section.

9 (9) By September 30, 2022, the department of health and human  
10 services must provide a report to the house and senate  
11 appropriations committees, the house and senate fiscal agencies,  
12 and the state budget office on the overall efficacy of the funds  
13 appropriated in this section, including, but not limited to, the  
14 statewide outcomes of recruitment efforts, retention efforts, and  
15 training efforts to reduce statewide health care staffing  
16 vacancies. The Michigan Health and Hospital Association and other  
17 recipients shall provide data and metrics, in a manner approved by  
18 the department, to fulfill the reporting requirements of this  
19 section.

20 Sec. 307. From the funds appropriated in part 1 for ARP -  
21 nursing facility room conversion pilot project, the department of  
22 health and human services shall allocate \$10,000,000.00 as a  
23 competitive grant program to reimburse nursing facilities that are  
24 awarded these grants for 50% of the cost for nursing facilities to  
25 convert multi-resident rooms into single resident rooms. The  
26 department of health and human services shall prioritize awarding  
27 competitive grants for the conversion of rooms that have more than  
28 2 residents into single resident rooms.

29 Sec. 308. From the funds appropriated in part 1 for ARP -

1 nursing home respirators, the department of health and human  
2 services shall allocate \$5,000,000.00 to assist nursing facilities,  
3 assisted living facilities, and other long-term care facilities in  
4 complying with Occupational Safety and Health Administration  
5 respiratory protection standards.

6 Sec. 310. (1) The department shall allocate funds appropriated  
7 in part 1 for ARP - vaccine support to local public health  
8 departments for education, outreach, and other community engagement  
9 strategies.

10 (2) To the greatest extent allowed under federal rules and  
11 regulations, any vaccine education, outreach, and other community  
12 engagement strategies must be inclusive of other broader COVID-19  
13 education, outreach, and other community engagement strategies,  
14 including early treatment options, testing, and other mitigation  
15 strategies.

16 (3) The department shall not allocate funds in this section to  
17 local public health departments for which a county board of  
18 commissioners has passed a resolution rejecting these funds, if the  
19 rejection of these funds has occurred within 30 days of the  
20 effective date of this act.

21 (4) A recipient of a COVID-19 vaccine administered from the  
22 funds appropriated in part 1 for ARP - vaccine support shall be  
23 provided with information regarding or informed if and in what  
24 manner the development of the vaccine utilized aborted fetal tissue  
25 or human embryonic stem cell derivation lines.

26 (5) The unexpended funds appropriated in part 1 for ARP -  
27 vaccine support are designated as a work project appropriation, and  
28 any unencumbered or unallotted funds shall not lapse at the end of  
29 the fiscal year and shall be available for expenditures for

1 projects under this section until the projects have been completed.  
2 The following is in compliance with section 451a of the management  
3 and budget act, 1984 PA 431, MCL 18.1451a:

4 (a) The purpose of the project is to increase vaccine  
5 education, outreach, and other community engagement strategies and  
6 must be inclusive of other broader COVID-19 education, outreach,  
7 and other community engagement strategies, including early  
8 treatment options, testing, and other mitigation strategies.

9 (b) The project will be accomplished by utilizing local public  
10 health departments.

11 (c) The total estimated cost of the project is \$54,143,900.00.

12 (d) The tentative completion date is September 30, 2026.

13 Sec. 311. (1) From the funds appropriated in part 1 for MI  
14 Choice waiver program presumptive eligibility risk pool, and to the  
15 greatest extent allowable under E-FMAP, the department of health  
16 and human services shall allocate \$5,000,000.00 to develop and  
17 implement a pilot risk pool in no fewer than 2 service areas to  
18 cover 90% of MI Choice waiver agents' exposure to financial losses  
19 in those service areas for up to 6 weeks of services costs  
20 associated with incorrect presumptive eligibility determinations.

21 (2) Any MI Choice waiver agent in the pilot service areas  
22 that, at any point in time, incorrectly presumes eligibility for  
23 not less than 20% of its enrollees is not eligible for funding from  
24 this project for the balance of this project's term.

25 Sec. 312. (1) From the funds appropriated in part 1 for ARP -  
26 Morris Hood kidney foundation, the department of health and human  
27 services shall provide \$14,000,000.00 in support to the National  
28 Kidney Foundation of Michigan for a multiyear initiative to  
29 implement the chronic kidney disease prevention initiative that was

1 adopted by the department of health and human services and the  
2 National Kidney Foundation of Michigan in March 2021. This  
3 initiative, administered by the National Kidney Foundation of  
4 Michigan and its partners, shall be known as the Morris Hood III  
5 chronic kidney disease prevention initiative.

6 (2) The Morris Hood III chronic kidney disease prevention  
7 initiative shall do all of the following:

8 (a) Create a collaborative and comprehensive kidney disease  
9 prevention and awareness system, including a focus on communities  
10 at the greatest risk of kidney disease and those facing health  
11 disparities.

12 (b) Increase knowledge, awareness, and understanding of  
13 preventable kidney disease, increase adoption of evidence-based  
14 strategies to reduce chronic kidney disease, and identify financial  
15 sustainability strategies for chronic kidney disease detection,  
16 management, and prevention.

17 (c) Identify patients at risk of developing chronic kidney  
18 disease through collaboration with the department of health and  
19 human services making use of Michigan Medicaid data, kidney disease  
20 data, lab data, and shared metrics from partner organizations.

21 (d) Develop a cost-benefit analysis on the strategies  
22 identified to reduce preventable kidney disease or mitigate the  
23 effect of kidney disease.

24 (3) Under the Morris Hood III chronic kidney disease  
25 prevention initiative, the department of health and human services  
26 shall work with the National Kidney Foundation of Michigan to do  
27 all of the following:

28 (a) Establish a statewide advisory committee to assist in the  
29 implementation of the initiative, drawing from consumers,



1 providers, and advocates.

2 (b) Cooperate in sharing appropriate and timely data to enable  
3 the initiative to target resources effectively.

4 (c) Produce an annual status report to be shared with the  
5 legislature and interested parties.

6 (d) Convene periodic meetings with providers to assure  
7 awareness of the initiative and its targeted population.

8 (e) Cooperate with Michigan's Medicaid health plans to  
9 identify populations most at risk for kidney disease.

10 Sec. 313. From the funds appropriated in part 1 for ARP -  
11 hospital airborne pathogen control program, \$10,000,000.00 shall be  
12 allocated to hospitals for in-room ceiling installations and  
13 internet of things-connected Michigan-based ultraviolet control  
14 technology filtration and cleaning systems or other devices that  
15 reduce surface pathogens and airborne contaminants for control of  
16 harmful pathogens in the air and on settled surfaces. The program  
17 shall be designed to meet all of the following parameters:

18 (a) The program shall be a pilot program.

19 (b) Hospitals and health systems that were in the top 10  
20 hospitals/health systems in the number of COVID patients treated in  
21 the state in calendar year 2021 and that have submitted letters of  
22 intent to utilize this technology to the Michigan department of  
23 health and human services by April 1, 2022 shall be given priority  
24 for allocations.

25 (c) Allocation of these funds should be made through 2 equal  
26 grants to qualified applicants.

27 (d) Hospitals participating in the pilot program shall track  
28 the outcome metrics as defined during grant submission.

29 Sec. 314. (1) From the funds appropriated in part 1 for ARP -

1 adult foster care and homes for the aged COVID-19 relief, the  
2 department of health and human services shall establish a process  
3 to provide a \$700.00 per bed grant to eligible facilities as  
4 defined in subsection (4) to cover COVID-19 pandemic costs.

5 (2) The department of health and human services shall develop  
6 an application form for the funding.

7 (3) Eligible facilities must fill out and submit the  
8 application form referenced in subsection (2) to the department of  
9 health and human services within 90 days of the effective date of

21 health units, the department of health and human services shall  
22 allocate \$4,000,000.00 to a public university located in a city  
23 with a population greater than 500,000 according to the most recent  
24 federal decennial census to help create a Michigan mobile health  
25 corps program.

26 (2) The Michigan mobile health corps shall be a collaborative  
27 to help address health disparities among populations with limited  
28 access to medical care and social services resources in Southeast  
29 Michigan.

1           Sec. 316. (1) From the funds appropriated in part 1 for ARP -  
2 supplemental payments to private child caring institutions,  
3 \$6,200,000.00 shall be awarded as a supplemental payment adjustment  
4 to contracted child caring institutions for abuse, neglect, and  
5 juvenile justice services to address the economic impact of the  
6 COVID-19 public health emergency.

7           (2) From the funds appropriated in part 1 for ARP -  
8 supplemental payments to private child caring institutions,  
9 \$2,000,000.00 shall be awarded to a qualified residential treatment  
10 program that has been in existence for at least 75 years and is  
11 located in a city with a population of between 57,000 and 58,000  
12 located in a county with a population of greater than 1,500,000  
13 according to the 2010 federal decennial census. Funding in this  
14 subsection shall be paid to the qualifying entities within 30 days  
15 of the effective date of this act.

16           Sec. 317. (1) From the funds appropriated in part 1 for ARP -  
17 homeless shelter repair grants, the department of health and human  
18 services shall establish a grant program targeted to homeless  
19 shelter service providers. In making grants under this section, the  
20 department shall maximize to the greatest extent possible broad  
21 geographic distribution. Grants are intended to fund necessary  
22 physical improvements to homeless shelter facilities, including,  
23 but not limited to:

24           (a) Repairs to plumbing, electrical, and heating, ventilation,

6 (2) The unexpended funds appropriated in part 1 for ARP -  
7 homeless shelter repair grants are designated as a work project  
8 appropriation, and any unencumbered or unallotted funds shall not  
9 lapse at the end of the fiscal year and shall be available for  
10 expenditures for projects under this section until the projects  
11 have been completed. The following is in compliance with section  
12 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

13 (a) The purpose of the project is to fund physical  
14 improvements to facilities operated by homeless shelter service  
15 providers.

16 (b) The project will be accomplished by utilizing state  
17 employees or contracts.

18 (c) The total estimated cost of the project is \$10,000,000.00.

19 (d) The tentative completion date is September 30, 2026.

20 Sec. 318. (1) From the funds appropriated in part 1 for ARP -  
21 nursing home infection control grants, the department of health and  
22 human services shall allocate \$29,000,000.00 in grants to skilled  
23 nursing facilities. Grants shall fund structural and operational  
24 improvements to skilled nursing facilities that would help reduce  
25 the spread of infectious disease. Eligible projects include, but  
26 are not limited to, the following:

27 (a) Efforts to improve indoor air quality, including  
28 maintenance and improvements to indoor heating, ventilation, and  
29 air-conditioning systems.

1 (b) The creation of negative air pressure rooms.

2 (c) The creation of isolation areas in nursing homes for sick  
3 residents.

4 (d) The purchase and installation of technologies to reduce  
5 the spread of infectious disease.

6 (2) Individual nursing facilities are limited to no more than  
7 \$500,000.00 in funds allocated in subsection (1).

8 (3) The unexpended funds appropriated in part 1 for ARP -  
9 nursing home infection control grants are designated as a work  
10 project appropriation, and any unencumbered or unallotted funds  
11 shall not lapse at the end of the fiscal year and shall be  
12 available for expenditures for projects under this section until  
13 the projects have been completed. The following is in compliance  
14 with section 451a of the management and budget act, 1984 PA 431,

26 foster family homes or foster family group homes and unlicensed  
27 relative caregivers who are currently caring for a child placed in  
28 foster care and youth currently supported in independent living  
29 foster care arrangements.

1 (2) Payment of funds will be set at \$1,500.00 per child in a  
2 foster family home, foster family group home, or independent living  
3 arrangements.

4 (3) The unexpended funds appropriated in part 1 for ARP -  
5 child welfare mitigation payments are designated as a work project  
6 appropriation, and any unencumbered or unallotted funds shall not  
7 lapse at the end of the fiscal year and shall be available for  
8 expenditures for projects under this section until the projects  
9 have been completed. The following is in compliance with section

20 respite services home and community-based services waiver, the  
21 department of health and human services shall allocate  
22 \$20,000,000.00 for respite supports to in-home providers of  
23 department of health and human services-funded services to provide  
24 respite relief for families providing continuous direct care  
25 support to a family member.

26 (2) The unexpended funds appropriated in part 1 for ARP -  
27 respite services home and community-based services waiver are  
28 designated as a work project appropriation, and any unencumbered or  
29 unallotted funds shall not lapse at the end of the fiscal year and

1 shall be available for expenditures for projects under this section  
2 until the projects have been completed. The following is in
