

**SENATE SUBSTITUTE FOR  
HOUSE BILL NO. 5779**

A bill to amend 1979 PA 94, entitled  
"The state school aid act of 1979,"  
by amending sections 201 and 206 (MCL 388.1801 and 388.1806), as  
amended by 2021 PA 86.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 201. (1) Subject to the conditions set forth in this  
2 article, the amounts listed in this section are appropriated for  
3 community colleges for the fiscal year ending September 30, ~~2022,~~  
4 **2023**, from the funds indicated in this section. The following is a  
5 summary of the appropriations in this section:

 17       ~~state school aid fund.~~

18       ~~(b) For fiscal year 2021-2022, there is allocated an amount~~  
 19       ~~not to exceed \$11,700,000.00 for payments to participating~~  
 20       ~~community colleges, appropriated from the state school aid fund. A~~  
 21       ~~community college that receives money under this subdivision shall~~  
 22       ~~use that money solely for the purpose of offsetting the normal cost~~  
 23       ~~contribution rate.~~

 4 ~~this subsection shall accrue these payments to its institutional~~  
 5 ~~fiscal year ending June 30, 2022.~~

6       Sec. 206. (1) ~~Except for the funds appropriated in section~~  
 7 ~~201(4)(b), the~~ **The** funds appropriated in section 201 are  
 8 appropriated for community colleges with fiscal years ending June  
 9 30, ~~2022-2023~~ and shall be paid out of the state treasury and  
 10 distributed by the state treasurer to the respective community  
 11 colleges in 11 monthly installments on the sixteenth of each month,  
 12 or the next succeeding business day, beginning with October 16,  
 13 ~~2021-2022~~. Each community college shall accrue its July and August  
 14 ~~2022-2023~~ payments to its institutional fiscal year ending June 30,  
 15 ~~2022-2023~~.

16       ~~(2) The funds appropriated in section 201(4)(b) are~~  
 17 ~~appropriated for community colleges with fiscal years ending June~~  
 18 ~~30, 2022 and shall be distributed to the respective community~~  
 19 ~~colleges in quarterly installments on the sixteenth of each~~  
 20 ~~November, February, May, and August. Each community college shall~~  
 21 ~~accrue its August 2022 payments to its institutional fiscal year~~  
 22 ~~ending June 30, 2022.~~

23       **(2)** ~~(3)~~—If the state budget director determines that a  
 24 community college failed to submit any of the following information  
 25 in the form and manner specified by the center, the state treasurer  
 26 shall, subject to subsection ~~(4)~~, **(3)**, withhold the monthly  
 27 installments from that community college until those data are  
 28 submitted:

29       (a) The Michigan community colleges verified data inventory



1 data for the preceding academic year to the center by the first  
2 business day of November of each year as specified in section 217.

3 (b) The college credit opportunity data set as specified in  
4 section 209.

5 (c) The longitudinal data set for the preceding academic year  
6 to the center as specified in section 219.

7 (d) The annual independent audit as specified in section 222.

8 (e) Tuition and mandatory fees information for the current  
9 academic year as specified in section 225.

10 (f) The number and type of associate degrees and other  
11 certificates awarded during the previous academic year as specified  
12 in section 226.

13 **(3)** ~~(4)~~—The state budget director shall notify the chairs of  
14 the house and senate appropriations subcommittees on community  
15 colleges at least 10 days before withholding funds from any  
16 community college under subsection ~~(3)~~ **(2)**.
