SUBSTITUTE FOR HOUSE BILL NO. 5686

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

by amending section 18 (MCL 388.1618), as amended by 2021 PA 48.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 18. (1) Except as provided in another section of this
- 2 article, each district or other entity shall apply the money
- 3 received by the district or entity under this article to salaries
- 4 and other compensation of teachers and other employees, tuition,
- 5 transportation, lighting, heating, ventilation, water service, the
- 6 purchase of textbooks, other supplies, and any other school
- 7 operating expenditures defined in section 7. However, not more than
- 8 20% of the total amount received by a district under sections 22a
- 9 and 22b or received by an intermediate district under section 81

- 1 may be transferred by the board to either the capital projects fund
- 2 or to the debt retirement fund for debt service. A district or
- 3 other entity shall not apply or take the money for a purpose other
- 4 than as provided in this section. The department shall determine
- 5 the reasonableness of expenditures and may withhold from a
- 6 recipient of funds under this article the apportionment otherwise
- 7 due upon a violation by the recipient. A district must not be
- 8 prohibited or limited from using funds appropriated or allocated
- 9 under this article that are permitted for use for noninstructional
- 10 services to contract or subcontract with an intermediate district,
- 11 third party, or vendor for the noninstructional services.
- 12 (2) A district or intermediate district shall adopt an annual
- 13 budget in a manner that complies with the uniform budgeting and
- 14 accounting act, 1968 PA 2, MCL 141.421 to 141.440a. Within 15 days
- 15 after a district board adopts its annual operating budget for the
- 16 following school fiscal year, or after a district board adopts a
- 17 subsequent revision to that budget, the district shall make all of
- 18 the following available through a link on its website homepage, or
- 19 may make the information available through a link on its
- 20 intermediate district's website homepage, in a form and manner
- 21 prescribed by the department:
- 22 (a) The annual operating budget and subsequent budget
- 23 revisions.
- 24 (b) Using data that have already been collected and submitted
- 25 to the department, a summary of district expenditures for the most
- 26 recent fiscal year for which they are available, expressed in the
- 27 following 2 visual displays:
- 28 (i) A chart of personnel expenditures, broken into the
- 29 following subcategories:

- 1 (A) Salaries and wages.
- 2 (B) Employee benefit costs, including, but not limited to,
- 3 medical, dental, vision, life, disability, and long-term care
- 4 benefits.
- 5 (C) Retirement benefit costs.
- 6 (D) All other personnel costs.
- 7 (ii) A chart of all district expenditures, broken into the
- 8 following subcategories:
- 9 (A) Instruction.
- 10 (B) Support services.
- 11 (C) Business and administration.
- 12 (D) Operations and maintenance.
- 13 (c) Links to all of the following:
- (i) The current collective bargaining agreement for each
- 15 bargaining unit.
- 16 (ii) Each health care benefits plan, including, but not limited
- 17 to, medical, dental, vision, disability, long-term care, or any
- 18 other type of benefits that would constitute health care services,
- 19 offered to any bargaining unit or employee in the district.
- 20 (iii) The audit report of the financial audit conducted under
- 21 subsection (4) for the most recent fiscal year for which it is
- 22 available.
- (iv) The bids required under section 5 of the public employees
- 24 health benefit act, 2007 PA 106, MCL 124.75.
- 25 (v) The district's written policy governing procurement of
- 26 supplies, materials, and equipment.
- 27 (vi) The district's written policy establishing specific
- 28 categories of reimbursable expenses, as described in section
- 29 1254(2) of the revised school code, MCL 380.1254.

- 1 (vii) Either the district's accounts payable check register for
- 2 the most recent school fiscal year or a statement of the total
- 3 amount of expenses incurred by board members or employees of the
- 4 district that were reimbursed by the district for the most recent
- 5 school fiscal year.
- 6 (d) The total salary and a description and cost of each fringe
- 7 benefit included in the compensation package for the superintendent
- 8 of the district and for each employee of the district whose salary
- 9 exceeds \$100,000.00.
- 10 (e) The annual amount spent on dues paid to associations.
- 11 (f) The annual amount spent on lobbying or lobbying services.
- 12 As used in this subdivision, "lobbying" means that term as defined
- 13 in section 5 of 1978 PA 472, MCL 4.415.
- 14 (g) Any deficit elimination plan or enhanced deficit
- 15 elimination plan the district was required to submit under the
- 16 revised school code.
- 17 (h) Identification of all credit cards maintained by the
- 18 district as district credit cards, the identity of all individuals
- 19 authorized to use each of those credit cards, the credit limit on
- 20 each credit card, and the dollar limit, if any, for each
- 21 individual's authorized use of the credit card.
- 22 (i) Costs incurred for each instance of out-of-state travel by
- 23 the school administrator of the district that is fully or partially
- 24 paid for by the district and the details of each of those instances
- 25 of out-of-state travel, including at least identification of each
- 26 individual on the trip, destination, and purpose.
- 27 (3) For the information required under subsection (2)(a),
- 28 (2)(b)(i), and (2)(c), an intermediate district shall provide the
- 29 same information in the same manner as required for a district

- 1 under subsection (2).
- 2 (4) For the purposes of determining the reasonableness of
- 3 expenditures, whether a district or intermediate district has
- 4 received the proper amount of funds under this article, and whether
- 5 a violation of this article has occurred, all of the following
- 6 apply:
- 7 (a) The department shall require that each district and
- 8 intermediate district have an audit of the district's or
- 9 intermediate district's financial and pupil accounting records
- 10 conducted at least annually, and at such other times as determined
- 11 by the department, at the expense of the district or intermediate
- 12 district, as applicable. The audits must be performed by a
- 13 certified public accountant or by the intermediate district
- 14 superintendent, as may be required by the department, or in the
- 15 case of a district of the first class by a certified public
- 16 accountant, the intermediate superintendent, or the auditor general
- 17 of the city. A district or intermediate district shall retain these
- 18 records for the current fiscal year and from at least the 3
- 19 immediately preceding fiscal years.
- 20 (b) If a district operates in a single building with fewer
- 21 than 700 full-time equated pupils, if the district has stable
- 22 membership, and if the error rate of the immediately preceding 2
- 23 pupil accounting field audits of the district is less than 2%, the
- 24 district may have a pupil accounting field audit conducted
- 25 biennially but must continue to have desk audits for each pupil
- 26 count. The auditor must document compliance with the audit cycle in
- 27 the pupil auditing manual. As used in this subdivision, "stable
- 28 membership" means that the district's membership for the current
- 29 fiscal year varies from the district's membership for the

- 1 immediately preceding fiscal year by less than 5%.
- 2 (c) A district's or intermediate district's annual financial
- 3 audit must include an analysis of the financial and pupil
- 4 accounting data used as the basis for distribution of state school
- **5** aid.
- 6 (d) The pupil and financial accounting records and reports,
- 7 audits, and management letters are subject to requirements
- 8 established in the auditing and accounting manuals approved and
- 9 published by the department.
- 10 (e) All of the following must be done not later than November
- 11 1 each year for reporting the prior fiscal year data:
- 12 (i) A district shall file the annual financial audit reports
- 13 with the intermediate district and the department.
- 14 (ii) The intermediate district shall file the annual financial
- 15 audit reports for the intermediate district with the department.
- 16 (iii) The intermediate district shall enter the pupil membership
- 17 audit reports for its constituent districts and for the
- 18 intermediate district, for the pupil membership count day and
- 19 supplemental count day, in the Michigan student data system.
- 20 (f) The annual financial audit reports and pupil accounting
- 21 procedures reports must be available to the public in compliance
- 22 with the freedom of information act, 1976 PA 442, MCL 15.231 to
- **23** 15.246.
- 24 (g) Not later than January 31 of each year, the department
- 25 shall notify the state budget director and the legislative
- 26 appropriations subcommittees responsible for review of the school
- 27 aid budget of districts and intermediate districts that have not
- 28 filed an annual financial audit and pupil accounting procedures
- 29 report required under this section for the school year ending in

- 1 the immediately preceding fiscal year.
- 2 (5) By the first business day in November of each fiscal year,
- 3 each district and intermediate district shall submit to the center,
- 4 in a manner prescribed by the center, annual comprehensive
- 5 financial data consistent with the district's or intermediate
- 6 district's audited financial statements and consistent with
- 7 accounting manuals and charts of accounts approved and published by
- 8 the department. For an intermediate district, the report must also
- 9 contain the website address where the department can access the
- 10 report required under section 620 of the revised school code, MCL
- 11 380.620. The department shall ensure that the prescribed Michigan
- 12 public school accounting manual chart of accounts includes standard
- 13 conventions to distinguish expenditures by allowable fund function
- 14 and object. The functions must include at minimum categories for
- 15 instruction, pupil support, instructional staff support, general
- 16 administration, school administration, business administration,
- 17 transportation, facilities operation and maintenance, facilities
- 18 acquisition, and debt service; and must include object
- 19 classifications of salary, benefits, including categories for
- 20 active employee health expenditures, purchased services, supplies,
- 21 capital outlay, and other. A district shall report the required
- 22 level of detail consistent with the manual as part of the
- 23 comprehensive annual financial report.
- 24 (6) By the last business day in September of each year, each
- 25 district and intermediate district shall file with the center the
- 26 special education actual cost report, known as "SE-4096", on a form
- 27 and in the manner prescribed by the center. An intermediate
- 28 district shall certify the audit of a district's report.
- 29 (7) By not later than 1 week after the last business day in

- 1 September of each year, each district and intermediate district
- 2 shall file with the center the audited transportation expenditure
- 3 report, known as "SE-4094", on a form and in the manner prescribed
- 4 by the center. An intermediate district shall certify the audit of
- 5 a district's report.
- 6 (8) The department shall review its pupil accounting and pupil
- 7 auditing manuals at least annually and shall periodically update
- 8 those manuals to reflect changes in this article. Any changes to
- 9 the pupil accounting manual that are applicable for the school year
- 10 that begins after March 31 of a fiscal year must be published by
- 11 not later than March 31 of that fiscal year. However, if
- 12 legislation is enacted that necessitates adjustments to the pupil
- 13 accounting manual after March 31 of a fiscal year, and a district
- 14 incurs a violation of the amended pupil accounting manual in the
- 15 subsequent fiscal year, the department must notify the district of
- 16 that violation and allow the district 30 days to correct the
- 17 violation before the department is allowed to impose financial
- 18 penalties under this act related to the violation.department's
- 19 pupil accounting and pupil auditing manual must be transmitted to
- 20 the chairs of the committees in the house and senate responsible
- 21 for education legislation before the changes take effect. A change
- 22 to the department's pupil accounting or pupil auditing manual must
- 23 not take effect during the school fiscal year in which the change
- 24 is made.
- 25 (9) If a district that is a public school academy purchases
- 26 property using money received under this article, the public school
- 27 academy shall retain ownership of the property unless the public
- 28 school academy sells the property at fair market value.
- 29 (10) If a district or intermediate district does not comply

- 1 with subsections (4), (5), (6), (7), and (12), or if the department
- 2 determines that the financial data required under subsection (5)
- 3 are not consistent with audited financial statements, the
- 4 department shall withhold all state school aid due to the district
- 5 or intermediate district under this article, beginning with the
- 6 next payment due to the district or intermediate district, until
- 7 the district or intermediate district complies with subsections
- 8 (4), (5), (6), (7), and (12). If the district or intermediate
- 9 district does not comply with subsections (4), (5), (6), (7), and
- 10 (12) by the end of the fiscal year, the district or intermediate
- 11 district forfeits the amount withheld.
- 12 (11) If a district or intermediate district does not comply
- 13 with subsection (2), the department may withhold up to 10% of the
- 14 total state school aid due to the district or intermediate district
- 15 under this article, beginning with the next payment due to the
- 16 district or intermediate district, until the district or
- 17 intermediate district complies with subsection (2). If the district
- 18 or intermediate district does not comply with subsection (2) by the
- 19 end of the fiscal year, the district or intermediate district
- 20 forfeits the amount withheld.
- 21 (12) By November 1 of each year, if a district or intermediate
- 22 district offers virtual learning under section 21f, or for a school
- 23 of excellence that is a cyber school, as defined in section 551 of
- 24 the revised school code, MCL 380.551, the district or intermediate
- 25 district shall submit to the department a report that details the
- 26 per-pupil costs of operating the virtual learning by vendor type
- 27 and virtual learning model. The report must include information
- 28 concerning the operation of virtual learning for the immediately
- 29 preceding school fiscal year, including information concerning

- 1 summer programming. Information must be collected in a form and
- 2 manner determined by the department and must be collected in the
- 3 most efficient manner possible to reduce the administrative burden
- 4 on reporting entities.
- 5 (13) By March 31 of each year, the department shall submit to
- 6 the house and senate appropriations subcommittees on state—school
- 7 aid, the state budget director, and the house and senate fiscal
- 8 agencies a report summarizing the per-pupil costs by vendor type of
- 9 virtual courses available under section 21f and virtual courses
- 10 provided by a school of excellence that is a cyber school, as
- 11 defined in section 551 of the revised school code, MCL 380.551.
- 12 (14) As used in subsections (12) and (13), "vendor type" means
- 13 the following:
- 14 (a) Virtual courses provided by the Michigan Virtual
- 15 University.
- 16 (b) Virtual courses provided by a school of excellence that is
- 17 a cyber school, as defined in section 551 of the revised school
- 18 code, MCL 380.551.
- 19 (c) Virtual courses provided by third party vendors not
- 20 affiliated with a public school in this state.
- 21 (d) Virtual courses created and offered by a district or
- 22 intermediate district.
- 23 (15) An allocation to a district or another entity under this
- 24 article is contingent upon the district's or entity's compliance
- 25 with this section.
- 26 (16) The department shall annually submit to the senate and
- 27 house subcommittees on school aid and to the senate and house
- 28 standing committees on education an itemized list of allocations
- 29 under this article to any association or consortium consisting of

- 1 associations in the immediately preceding fiscal year. The report
- 2 must detail the recipient or recipients, the amount allocated, and
- 3 the purpose for which the funds were distributed.
