HOUSE BILL NO. 4325

February 24, 2021, Introduced by Rep. Hall and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1981 PA 180, entitled "Older Michiganians act,"

(MCL 400.581 to 400.594) by adding section 6l.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6l. (1) Beginning October 1, 2020, each area agency on
- 2 aging must conduct or cause to be conducted a criminal background
- 3 check that reveals information similar or substantially similar to
- 4 information found on an internet criminal history access tool

- 1 (ICHAT) check and a national and state sex offender registry check
- 2 for each new employee, employee, subcontractor, subcontractor
- 3 employee, or volunteer who has in-person client contact, in-home
- 4 client contact, access to a client's personal property, or access
- 5 to confidential client information.
- 6 (2) A criminal background check for a new hire or new
- 7 volunteer must be completed before the individual begins working
- 8 directly with a client or has access to a client's personal
- 9 property or confidential client information.
- 10 (3) Each area agency on aging must update criminal background
- 11 checks for all employees and volunteers every 3 years to identify a
- 12 conviction in the event a conviction occurs while an individual is
- 13 employed or providing volunteer service.
- 14 (4) An employee hired before or a volunteer who started
- 15 volunteering before October 1, 2020 must be screened within 90 days
- 16 after the effective date of the amendatory act that added this
- 17 section, unless the area agency on aging has conducted a criminal
- 18 background check on the employee or volunteer that meets the
- 19 requirements of a criminal background check described in this
- 20 section on or after October 1, 2020. After that, a criminal
- 21 background check for each employee and volunteer must be completed
- 22 no later than 30 days after every third anniversary from the date
- 23 of his or her last background check.
- 24 (5) An updated criminal background check for each employee
- 25 hired on or after or volunteer who started volunteering on or after
- 26 August 1, 2020 must be completed no later than 30 days after every
- 27 third anniversary of the employee's date of hire or volunteer's
- 28 start date.
- 29 (6) Information obtained from a criminal background check

- 1 shall only be used to determine suitability for employment or
- 2 volunteer opportunities. Each area agency on aging is required to
- 3 maintain a copy of the results of each criminal background check
- 4 for paid and volunteer staff in a confidential and controlled
- 5 access file. The information must not be used in violation of
- 6 applicable federal or state equal employment opportunity law or
- 7 regulation.
- 8 (7) An employee or volunteer must not be permitted to work
- 9 directly with a client or have access to a client's personal
- 10 property or confidential client information if 1 or more of the
- 11 following apply:
- 12 (a) The results of the criminal background check show that the
- 13 individual has a federal or state felony conviction related to 1 or
- 14 more of the following crimes:
- 15 (i) A crime against a vulnerable adult as set forth in chapter
- 16 XXA of the Michigan penal code, 1931 PA 328, MCL 750.145m to
- 17 750.145r.
- 18 (ii) A violent crime including, but not limited to, murder,
- 19 manslaughter, kidnapping, arson, assault, battery, or domestic
- 20 violence.
- 21 (iii) A financial crime including, but not limited to, fraud,
- 22 forgery, counterfeiting, embezzlement, or tax evasion.
- 23 (iv) A sex crime including, but not limited to, rape, sexual
- 24 abuse, criminal sexual conduct, or prostitution.
- 25 (v) Cruelty or torture.
- 26 (vi) Abuse or neglect.
- 27 (vii) Felony involving the use of a firearm or dangerous
- 28 weapon.
- 29 (b) The results of the criminal background check show that the

- 1 individual has a federal or state felony conviction within the
- 2 preceding 10 years from the date of the criminal background check,
- 3 including, but not limited to, 1 or more of the following:
- 4 (i) A crime involving a state, federal, or local government
- 5 assistance program.
- 6 (ii) A theft crime including, but not limited to, larceny,
- 7 burglary, robbery, extortion, false pretenses, false
- 8 representation, or conversion.
- 9 (iii) A drug crime including, but not limited to, possession,
- 10 delivery, or manufacturing.
- 11 (c) The results of the criminal background check show that the
- 12 individual has a federal or state misdemeanor conviction within the
- 13 preceding 5 years from the date of the criminal background check,
- 14 including, but not limited to, 1 or more of the following:
- 15 (i) A crime involving a state, federal, or local government
- 16 assistance program.
- 17 (ii) A crime against a vulnerable adult as set forth in chapter
- 18 XXA of the Michigan penal code, 1931 PA 328, MCL 750.145m to
- 19 750.145r.
- 20 (iii) A financial crime including, but not limited to, fraud,
- 21 forgery, counterfeiting, embezzlement, or tax evasion.
- 22 (iv) A theft crime including, but not limited to, larceny,
- 23 burglary, robbery, extortion, false pretenses, false
- 24 representation, or conversion.
- 25 (v) A sex crime including, but not limited to, rape, sexual
- 26 abuse, criminal sexual conduct, or prostitution.
- 27 (vi) A drug crime including, but not limited to, possession,
- 28 delivery, or manufacturing.
- 29 (vii) Cruelty or torture.

- 1 (viii) Abuse or neglect.
- 2 (ix) Home invasion.

- 3 (x) Assault or battery.
- 4 (xi) A misdemeanor involving using a firearm or dangerous
 5 weapon with intent to injure, using a firearm or dangerous weapon
 6 that results in a personal injury, or using force or violence or
- 7 the threat of using force or violence.
- 8 (8) For the purposes of the excluded offenses identified in 9 subsection (7), an individual is considered to have been convicted 10 of a criminal offense if 1 of the following occurs:
- 11 (a) A judgment of conviction has been entered against the 12 individual by a federal, state, tribal, or local court regardless 13 of whether there is an appeal pending.
- 14 (b) There has been a finding of guilt against the individual 15 by a federal, state, tribal, or local court.
- 16 (c) A plea of guilty or nolo contendere by the individual has 17 been accepted by a federal, state, tribal, or local court.
- 18 (9) An arrest record alone does not disqualify an individual 19 from employment with or volunteering at an area agency on aging.
 - (10) Each area agency on aging is required to maintain documentation of all criminal background checks, including a list of all paid and volunteer staff that are subject to this section, the date of the most recently completed criminal background check, and the source of the criminal background check. An employee hired before October 1, 2020 is not exempt from the requirements of this section.
