PROVISIONS CONCERNING APPROPRIATIONS

**GENERAL SECTIONS**

12           Sec. 201. Pursuant to section 30 of article IX of the state  
13 constitution of 1963, total state spending from state sources under  
14 part 1 for the fiscal year ending September 30, 2022 is  
15 \$50,000,000.00 and total state spending from state sources to be  
16 paid to local units of government is \$50,000,000.00.

17           Sec. 202. The appropriations made and expenditures authorized  
18 under this part and part 1 and the departments, commissions,  
19 boards, offices, and programs for which appropriations are made  
20 under this part and part 1 are subject to the management and budget  
21 act, 1984 PA 431, MCL 18.1101 to 18.1594.

**DEPARTMENT OF STATE POLICE**

24           Sec. 301. Funds appropriated in part 1 for grants to cities  
25 for hiring law enforcement officers must be used to assist city  
26 public safety entities, through a competitive grant process, with  
27 hiring additional law enforcement officers. Entities receiving  
28 funding under this section are required to expand the number of law  
29 enforcement officer positions dedicated to road patrol and are

1 required to resume face-to-face visitation in their local jails.

2       Sec. 302. Funds appropriated in part 1 for grants to counties  
3 for hiring law enforcement officers must be used to assist county  
4 public safety entities, through a competitive grant process, with  
5 hiring additional law enforcement officers. Entities receiving  
6 funding under this section are required to expand the number of law  
7 enforcement officer positions dedicated to road patrol and are  
8 required to resume face-to-face visitation in their county jails.
