A bill to amend 1986 PA 268, entitled "Legislative council act,"

(MCL 4.1101 to 4.1901) by adding section 115.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 115. (1) Under the Michigan legislative state medal
- 2 program established under section 113, the legislature may award
- 3 the Michigan legislative medal of honor.
- 4 (2) The Michigan legislative medal of honor is the highest
- 5 legislatively issued military award of this state. All of the
- 6 following apply to the awarding of the medal:

- 1 (a) The medal may be awarded to a living or deceased service 2 member who satisfies any of the following requirements:
- 3 (i) Was born in this state.
- 4 (ii) Was a resident of this state when the service member 5 entered military service.
- 6 (iii) Died in this state.

- 7 (b) The medal must be awarded to a service member who
  8 voluntarily performs a deed of personal bravery or self-sacrifice
  9 involving risk of life that is so conspicuous as to clearly
  10 distinguish the service member for gallantry and intrepidity above
  11 the service member's comrades. Awarding of the medal must be
  12 determined in accordance with the standard of extraordinary merit.
- 13 The medal may be awarded only on incontestable proof of performance
  14 of the deed.
- 15 (c) The legislature may award the medal by concurrent 16 resolution. The legislature shall not, during a single regular 17 session, award the medal to more than the following 2 individuals:
- 18 (i) One service member who served between January 1, 1836 and 19 December 31, 1955.
  - (ii) One service member who served on or after January 1, 1956.
  - (d) Upon passage of the concurrent resolution described in subdivision (c), the speaker of the house of representatives and the senate majority leader shall award the medal in the presence of the legislator or legislators who sponsored the concurrent resolution and the representative and senator of the district where the individual being awarded the medal resides or last resided.
- 27 (e) If the legislature determines that a recommendation does 28 not meet the standards for awarding the medal, the legislature may 29 determine that the recommendation meets the standards for the

- 2 (3) The council administrator, or his or her designee, shall
- 3 submit 4 proposed designs for the medal to the speaker of the house
- 4 of representatives and the senate majority leader. The speaker of

- 6 determine the final design for the medal.
- 7 (4) As used in this section:
- 8 (a) "Medal" means the Michigan legislative medal of honor
- 9 described in subsection (1).

- (c) "United States Armed Forces" means the United States Army,
