- 2 expand support for new teachers, improve their instructional
- 3 practices, and improve teacher retention.
- 4 (2) From the allocation under subsection (1), the department
- 5 shall partner with educator preparation programs provided by public
- 6 institutions of higher education, districts, or districts in
- 7 partnership with an institution of higher education or an
- 8 alternative educator preparation program to provide coaching and a
- 9 cohort system of support to students in educator preparation
- 10 programs and new teachers. The services described in this
- 11 subsection must be free and must continue to be available for at
