- (B) The average number of days between the date the administrative law judge issued his or her decision and the date the unemployment agency began or resumed paying benefits to the claimant, as applicable.
- (C) The total number of appeals that the unemployment agency appealed to the unemployment insurance appeals commission.
- (b) The average number of days between the date the administrative law judge issued his or her decision and the date the unemployment agency began or resumed paying benefits to the claimant, as applicable.

- 2 (ii) The unemployment agency has not begun paying benefits to 3 the claimant or, if the unemployment agency ceased paying benefits 4 to the claimant, has not resumed paying benefits to the claimant.
 - (2) The unemployment agency shall not include any personal identifying information in a report submitted under subsection (1).
 - (3) As used in this section:
 - (a) "Office of the unemployment insurance citizens' advocate" means the office of the unemployment insurance citizens' advocate created under section 5 of the unemployment insurance citizens' advocate act.
 - (b) "Personal identifying information" means that term as defined in section 3 of the unemployment insurance citizens' advocate act.
