## **SENATE BILL NO. 1233**

November 29, 2022, Introduced by Senator SCHMIDT and referred to the Committee on Economic and Small Business Development.

A bill to amend 2014 PA 138, entitled "Workforce opportunity wage act,"

by amending sections 4 and 4d (MCL 408.414 and 408.414d); and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) Subject to the exceptions specified in this act,
- 2 the minimum hourly wage rate is:
- 3 (a) Before September 1, 2014, \$7.40.
- 4 (b) Beginning September 1, 2014, \$8.15.
- 5 (c) Beginning January 1, 2016, \$8.50.

- 1 (d) Beginning January 1, 2017, \$8.90.
- 2 (e) Beginning January 1, 2018, \$9.25.
- 3 (f) Beginning on the effective date of the amendatory act that 4 added this subdivision, \$12.00.
- 5 (2) Every January beginning in January <del>2019, 2024</del>, the state 6 treasurer shall adjust the minimum wage by an amount determined by 7 the state treasurer at the end of the preceding calendar year to 8 reflect the average annual percentage change in the consumer price 9 index Consumer Price Index for the most recent 5-year period for 10 which data are available. As used in this subsection, "consumer 11 price index" "Consumer Price Index" means the most comprehensive 12 index of consumer prices available for the midwest Midwest region 13 from the bureau of labor statistics Bureau of Labor Statistics of 14 the United States department of labor. Department of Labor. The 15 wage and hours division of the department of licensing and 16 regulatory affairs—labor and economic opportunity shall post the adjusted minimum wage on its website by February 1 of the year it 17 18 is calculated, and the adjusted rate is effective beginning April 1 19 of that year. An annual increase under this subsection shall not exceed 3.5%. 20
- 21 (3) An increase in the minimum hourly wage rate as prescribed 22 in subsection (2) does not take effect if the unemployment rate 23 determined by the bureau of labor statistics, Bureau of Labor 24 Statistics of the United States department of labor, Department of 25 Labor for this state is 8.5% or greater for the year preceding the 26 year of the prescribed increase.
- Sec. 4d. (1) Before September 1, 2014, the minimum hourly wage rate is \$2.65 per hour and, except as otherwise provided in subsection (2), beginning September 1, 2014, the minimum hourly

- 5 Enacting section 1. The improved workforce opportunity wage
- 6 act, 2018 PA 337, MCL 408.931 to 408.945, is repealed.
