## SENATE RESOLUTION NO.101

Senator Theis offered the following resolution:

- 1 A resolution to condemn President Biden's authoritarian Head
- 2 Start Vaccine and Mask Mandate and call upon Governor Gretchen
- 3 Whitmer and Attorney General Dana Nessel to take action against
- 4 this egregious federal overreach.
- 5 Whereas, After initially rejecting vaccine mandates, President
- 6 Joe Biden declared that his "patience" with unvaccinated Americans
- 7 was "wearing thin" as he announced a number of mandates, including
- 8 for Head Start programs. The Head Start Mandate requires all Head
- 9 Start staff, volunteers, and contractors to be vaccinated and all
- 10 individuals two years or older to wear masks; and
- 11 Whereas, The Head Start Mandate is a blatant overreach of
- 12 executive authority. The Founding Fathers gave Congress the power
- 13 to make laws, not the executive branch. Allowing the President to

- enact law by decree on a whim or when they "lose patience" with 1 Americans would fundamentally alter our system of government; and 2 Whereas, The Head Start Mandate infringes on the rights of 3 states protected by the United States Constitution. Under the Tenth 4 5 Amendment, states retain all powers that are not granted to the 6 federal government. Allowing the Head Start Mandate to take effect 7 would radically alter the relationship between states and the 8 federal government; and 9 Whereas, The Head Start Mandate serves no public health 10 purpose and will result in resistance, not compliance. The 11 continued use of oppressive policies, such as mandates, in the face of another COVID-19 variant and the third year of the Pandemic 12 reveals that the policy's true purpose is control rather than 13 14 public health. Such policies are particularly alarming and 15 destructive when directed at our nation's young children; and 16 Whereas, Despite the Head Start Mandate's dubious legality, Governor Gretchen Whitmer and Attorney General Dana Nessel have 17 18 continued to acquiesce to the Biden Administration's intrusion upon 19 our state's sovereign lawmaking authority and refused to stand up 20 for the rule of law. To date, two federal courts have enjoined 21 enforcement of the Head Start Mandate, effectively prohibiting its 22 enforcement in the twenty-five states that challenged the mandate. 23 As a result, federal mandates that are not currently effective only 24 a few miles away in the State of Ohio continue to be imposed upon 25 Michiganders; now, therefore, be it Resolved by the Senate, That we condemn President Biden's 26 27 authoritarian Head Start Vaccine and Mask Mandate; and be it

- 3 pursue all available avenues to stop enforcement of President
