Rep. Wozniak offered the following resolution:

**House Resolution No. 289.**

A resolution to declare June 27, 2024, as Public Employee Freedom Day in the state of Michigan.

Whereas, The Supreme Court of the United States issued its landmark decision in *JANUS v. AFSCME* on June 27, 2018, affirming the constitutional rights of public sector employees regarding union membership and dues; and

Whereas, The principles of free speech and freedom of association guaranteed by the First Amendment ensure that public sector employees have the right to make decisions that are in their best interest; and

Whereas, Freedom in decision making empowers public sector workers by granting them the ability to make individual choices regarding their representation, fostering a climate of transparency and accountability within public sector unions; and

Whereas, Safeguarding employee choices in representation protects jobs and has contributed to a more equitable workplace environment by safeguarding the rights of dissenting employees and protecting their freedom from compelled political speech; and

Whereas, Michigan had the foresight to ensure workplace freedom for public sector employees six years before the *JANUS* decision, further demonstrating Michigan's unwavering dedication to the principles of fairness and competition in employment; and

Whereas, The principles articulated in the *JANUS* decision continue to resonate as a cornerstone of constitutional jurisprudence, serving as a bulwark against coercion and ensuring the protection of individual liberties; and

Whereas, June 27th marks the sixth anniversary of the *JANUS* court decision as it continues to have a profound impact on safeguarding the constitutional rights of public sector employees across the United States; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare June 27, 2024, as Public Employee Freedom Day in the state of Michigan.

The resolution was referred to the Committee on Government Operations.

Was read a second time, and the question being on the adoption of the proposed substitute (H-1) previously recommended by the Committee on Regulatory Reform,

The substitute (H-1) was adopted, a majority of the members serving voting therefor.

**Senate Bill No. 662, entitled**

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 30701, 30716, and 30717 (MCL 324.30701, 324.30716, and 324.30717), section 30701 as added by 1995 PA 59, section 30716 as amended by 2002 PA 216, and section 30717 as amended by 2002 PA 217.

Was read a second time, and the question being on the adoption of the proposed substitute (H-3) previously recommended by the Committee on Natural Resources, Environment, Tourism and Outdoor Recreation,

The substitute (H-3) was adopted, a majority of the members serving voting therefor.

Rep. Phil Green moved to amend the bill as follows:

The substitute (H-1) was adopted, a majority of the members serving voting therefor.

The motion prevailed and the substitute (H-2) was adopted, a majority of the members serving voting therefor.

Rep. Brenda Carter moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

**Senate Bill No. 393, entitled**

A bill to amend 1994 PA 451, entitled “Natural resources and environmental protection act,” by repealing part 26 (MCL 324.2601 to 324.2611).

The bill was read a second time.

Rep. Wilson moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

**Senate Bill No. 394, entitled**

A bill to amend 1994 PA 451, entitled “Natural resources and environmental protection act,” by amending sections 1301, 1307, and 1311 (MCL 324.1301, 324.1307, and 324.1311), section 1301 as amended by 2018 PA 451, section 1307 as amended by 2018 PA 631, and section 1311 as amended by 2018 PA 268; and to repeal acts and parts of acts.

The bill was read a second time.

Rep. Wilson moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

**House Bill No. 5661, entitled**

A bill to regulate the online sale of tickets for entertainment events; to prohibit certain methods, acts, and practices in the sale or purchase of tickets for entertainment events; and to prohibit the use of a bot to make certain purchases for tickets for entertainment events.

Was read a second time, and the question being on the adoption of the proposed substitute (H-1) previously recommended by the Committee on Regulatory Reform,

The substitute (H-1) was adopted, a majority of the members serving voting therefor.

Rep. McFall moved to substitute (H-2) the bill.

The motion prevailed and the substitute (H-2) was adopted, a majority of the members serving voting therefor.

Rep. McFall moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

**House Bill No. 5662, entitled**

A bill to provide for certain investigations for violating the event online ticket sales act; to prescribe the powers and duties of certain state agencies and departments; and to prescribe civil sanctions and provide certain remedies.

Was read a second time, and the question being on the adoption of the proposed substitute (H-1) previously recommended by the Committee on Regulatory Reform,

The substitute (H-1) was adopted, a majority of the members serving voting therefor.

Rep. Filler moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

#### **House Bill No. 5733, entitled**

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending the title and section 219 (MCL 257.219), as amended by 2018 PA 74, and by adding sections 820a and 820b.

The bill was read a second time.

Rep. Beson moved to amend the bill as follows:

1. Amend page 4, line 22, after "of" by striking out "a" and inserting "an international".

2. Amend page 6, line 26, after "on" by striking out "a toll bridge or tunnel" and inserting "part of an international toll bridge or tunnel located".

3. Amend page 8, line 3, after "owned" by striking out "toll bridge or tunnel in this state" and inserting "international toll bridge or tunnel part of which is located in this state and".

4. Amend page 8, line 11, after "on" by striking out the balance of the line through "tunnel" on line 12 and inserting "part of an international toll bridge or tunnel located in this state".

The motion did not prevail and the amendments were not adopted, a majority of the members serving not voting therefor.

The motion prevailed.

The substitute (H-1) was adopted, a majority of the members serving voting therefor.

Rep. Wilson moved that the bill be placed on the order of Third Reading of Bills.

The motion prevailed.

**House Bill No. 5651, entitled**

A bill to amend 2000 PA 489, entitled "Michigan trust fund act," by amending sections 7 and 8 (MCL 12.257 and 12.258), section 7 as amended by 2023 PA 139 and section 8 as amended by 2014 PA 504.

Was read a second time, and the question being on the adoption of the proposed substitute (H-1) previously recommended by the Committee on Economic Development and Small Business,

The substitute (H-1) was adopted, a majority of the members serving voting therefor.
