FY 2022-23 Supplemental Appropriation Items

1. Federal Grants (Sec. 39a)

Authorizes a new \$27.9 million federal grant under the Every Student Succeeds Act (ESSA) to establish safer and healthier learning environments, and to prevent and respond to acts of bullying, violence, and hate. Total federal grants under this section equal \$780.2 million.

FY 2022-23 Supplemental Boilerplate Items

Sec. 22b. Foundation Allowances – REVISED

Revises technical language to clarify that funds are required to be deposited from the General Fund into the School Aid Fund for Community District Education Trust Fund costs in excess of \$72.0 million.

Sec. 147c(2). Michigan Public School Employees' Retirement System (MPERS) One-Time Payment – REVISED

Revises technical language to ensure a one-time \$1.0 billion payment into the retirement system is implemented correctly by flowing through all participating entities, including district libraries and community colleges, rather than being limited to districts and intermediate districts (ISDs).

Increases by \$500,000 SAF for a total of \$12.4 million SAF for reimbursements to districts that participate in the school breakfast program.
