

**SUBSTITUTE FOR
SENATE BILL NO. 494**

A bill to require the collection of certain residential and demographic information of incarcerated individuals and to require the information to be reported in a certain manner; and to provide for the powers and duties of certain state officers and entities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. As used in this act:

2 (a) "Commission" means the independent citizens redistricting
3 commission created under section 6 of article IV of the state
4 constitution of 1963.

5 (b) "Demographic data" means an individual's race, whether the
6 individual is of Hispanic or Latino origin, and whether the
7 individual is over the age of 18 years.

8 (c) "Department" means the department of corrections.



1 (d) "Geographic unit" means an area for which a population
2 count is reported in a federal decennial census and that contains a
3 correctional facility, federal reentry facility, or a pre-
4 incarceration address.

5 (e) "Incarcerated individual" means an individual under the
6 jurisdiction of the department who is incarcerated in a
7 correctional facility operated by the department.

8 (f) "Pre-incarceration address" means the address at which an
9 individual resided before the individual's current incarceration.

10 Sec. 2. (1) Beginning 6 months after the effective date of
11 this act, at the time an individual enters incarceration with the
12 department, the department shall collect the incarcerated
13 individual's pre-incarceration address and demographic data.

14 (2) No later than November 1 in the year immediately following
15 a federal decennial census, the department shall, for each
16 incarcerated individual who is incarcerated on the date of the
17 census, provide to the commission the individual's pre-
18 incarceration address and the geographic unit containing the
19 correctional facility in which the individual is incarcerated.

20 (3) No later than November 1 in the year immediately following
21 a federal decennial census, the department of state shall request
22 the United States Department of Justice to provide a report of the
23 following information that pertains to any individual who, on the
24 date of the census, either was incarcerated in a federal
25 correctional facility or contractual federal reentry center or was
26 under the supervision of the United States Department of Justice:

27 (a) The street address of the correctional facility or center
28 in which the individual was incarcerated or supervised.

29 (b) If applicable, the pre-incarceration address of the



1 individual.

2 (c) The demographic data for the individual.

3 (4) The department of state shall provide any report received
4 under subsection (3) to the commission.

5 (5) The commission may consider the information received under
6 this section in proposing a redistricting plan under section 6 of
7 article IV of the state constitution of 1963. If the commission
8 requests assistance, the department of technology, management, and
9 budget may provide assistance to the commission.

10 (6) The information provided to the commission under this
11 section must not be used in the distribution of funds from this
12 state or from the federal government.
