PROVISIONS CONCERNING APPROPRIATIONS

FOR FISCAL YEAR ENDING SEPTEMBER 30, 2024

GENERAL SECTIONS

12 Sec. 201. In accordance with section 30 of article IX of the
13 state constitution of 1963, for the fiscal year ending September
14 30, 2024, total state spending under part 1 from state sources is
15 \$27,339,100.00 and state spending under part 1 from state sources
16 to be paid to local units of government is \$20,219,100.00. The
17 following itemized statement identifies appropriations from which
18 spending to local units of government will occur:

22 Sec. 202. The appropriations under this part and part 1 are
23 subject to the management and budget act, 1984 PA 431, MCL 18.1101
24 to 18.1594.

MICHIGAN NATURAL RESOURCES TRUST FUND

27 Sec. 301. (1) The department of natural resources shall enter
28 into agreements with local units of government to administer the
29 grants identified in part 1. Among other provisions, the agreements



1 must require that grant recipients do all of the following:

2 (a) Dedicate to public outdoor recreation uses in perpetuity
3 the land acquired or developed.

4 (b) Replace lands converted or lost to other than public
5 outdoor recreation use.

6 (c) For parcels acquired that are larger than 5 acres, provide
7 this state with a nonparticipating 1/6 minimum royalty interest in
8 any acquired minerals that are retained by the grant recipient.

9 (2) The agreements under subsection (1) must also provide that
10 the full payments of grants be made only after proof of
11 acquisition, or proof of completion of a development project, is
12 submitted by the grant recipient and all costs are verified by the
13 department of natural resources. This requirement may be waived by
14 the department of natural resources.

15 Sec. 302. The appropriations in part 1 for capital outlay
16 shall be carried forward at the end of the fiscal year consistent
17 with the provisions of section 248 of the management and budget
18 act, 1984 PA 431, MCL 18.1248.

19 Sec. 303. (1) The state share of the following capital outlay
20 appropriations authorized in 2021 PA 9 for the following Michigan
21 natural resources trust fund projects that have since been
22 withdrawn by the grantee is reduced up to the amount indicated and
23 the money lapsed to the Michigan natural resources trust fund:

13 **DEPARTMENT OF NATURAL RESOURCES**

14 Sec. 401. (1) The department of natural resources may accept
 15 monetary and nonmonetary gifts, bequests, donations, contributions,
 16 or grants from any private or public source to support, in whole or
 17 in part, a departmental function or program to support
 18 appropriations in part 1. The department shall expend or use such
 19 gifts, bequests, donations, contributions, or grants for the
 20 purposes designated by the private or public source, if the purpose
 21 is specified.

22 (2) Amounts remaining from revenue collected by the department
 23 under this section that are unexpended and unencumbered must not
 24 lapse to the general fund but must be carried forward to the
 25 subsequent fiscal year.
