A bill to amend 1998 PA 386, entitled

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 1103. As used in this act:

2           (a) "1997 cost-of-living adjustment factor" means a fraction,  
3 the numerator of which is the United States Consumer Price Index  
4 for the prior calendar year and the denominator of which is the  
5 United States Consumer Price Index for 1997. As used in this  
6 subdivision, "United States Consumer Price Index" means the annual  
7 average of the United States Consumer Price Index for all urban  
8 consumers as defined and reported by the United States Department  
9 of Labor, Bureau of Labor Statistics, or its successor agency, and  
10 as certified by the state treasurer.

11           (b) "2023 cost-of-living adjustment factor" means a fraction,  
12 the numerator of which is the United States Consumer Price Index  
13 for the prior calendar year and the denominator of which is the  
14 United States Consumer Price Index for 2023. As used in this  
15 subdivision, "United States Consumer Price Index" means the annual  
16 average of the United States Consumer Price Index for all urban  
17 consumers as defined and reported by the United States Department  
18 of Labor, Bureau of Labor Statistics, or its successor agency, and  
19 as certified by the state treasurer.

1           **(c)** ~~(a)~~—"Agent" includes, but is not limited to, an attorney-  
2 in-fact under a durable or nondurable power of attorney and an  
3 individual authorized to make decisions as a patient advocate  
4 concerning another's health care.

5           **(d)** ~~(b)~~—"Application" means a written request to the probate  
6 register for an order of informal probate or informal appointment  
7 under part 3 of article III.

8           **(e)** ~~(c)~~—"Attorney" means, if appointed to represent a child  
9 under the provisions referenced in section 5213, an attorney  
10 serving as the child's legal advocate in the manner defined and  
11 described in section 13a of chapter XIIIA of the probate code of  
12 1939, 1939 PA 288, MCL 712A.13a.

13           **(f)** ~~(d)~~—"Beneficiary" includes, but is not limited to, the  
14 following:

15           *(i)* In relation to a trust, a person that is a trust  
16 beneficiary as defined in section 7103.

17           *(ii)* In relation to a charitable trust, a person that is  
18 entitled to enforce the trust.

19           *(iii)* In relation to a beneficiary of a beneficiary designation,  
20 a person that is a beneficiary of an insurance or annuity policy,  
21 of an account with POD designation, of a security registered in  
22 beneficiary form (TOD), of a pension, profit-sharing, retirement,  
23 or similar benefit plan, or of another nonprobate transfer at  
24 death.

25           *(iv)* In relation to a beneficiary designated in a governing  
26 instrument, a person that is a grantee of a deed, devisee, trust  
27 beneficiary, beneficiary of a beneficiary designation, donee,  
28 appointee, taker in default of a power of appointment, or person in  
29 whose favor a power of attorney or power held in an individual,

1 fiduciary, or representative capacity is exercised.

2 (g) ~~(e)~~—"Beneficiary designation" means the naming in a  
3 governing instrument of a beneficiary of an insurance or annuity  
4 policy, of an account with POD designation, of a security  
5 registered in beneficiary form (TOD), of a pension, profit-sharing,  
6 retirement, or similar benefit plan, or of another nonprobate  
7 transfer at death.

8 (h) ~~(f)~~—"Child" includes, but is not limited to, an individual  
9 entitled to take as a child under this act by intestate succession  
10 from the parent whose relationship is involved. Child does not  
11 include an individual who is only a stepchild, a foster child, or a  
12 grandchild or more remote descendant.

13 (i) ~~(g)~~—"Claim" includes, but is not limited to, in respect to  
14 a decedent's or protected individual's estate, a liability of the  
15 decedent or protected individual, whether arising in contract,  
16 tort, or otherwise, and a liability of the estate that arises at or  
17 after the decedent's death or after a conservator's appointment,  
18 including funeral and burial expenses and costs and expenses of  
19 administration. Claim does not include an estate or inheritance  
20 tax, or a demand or dispute regarding a decedent's or protected  
21 individual's title to specific property alleged to be included in  
22 the estate.

23 (j) ~~(h)~~—"Conservator" means a person appointed by a court to  
24 manage a protected individual's estate.

25 ~~(i) "Cost-of-living adjustment factor" means a fraction, the~~  
26 ~~numerator of which is the United States consumer price index for~~  
27 ~~the prior calendar year and the denominator of which is the United~~  
28 ~~States consumer price index for 1997. As used in this subdivision,~~  
29 ~~"United States consumer price index" means the annual average of~~

1 ~~the United States consumer price index for all urban consumers as~~  
2 ~~defined and reported by the United States department of labor,~~  
3 ~~bureau of labor statistics, or its successor agency, and as~~  
4 ~~certified by the state treasurer.~~

5       **(k)** ~~(j)~~—"Court" means the probate court or, when applicable,  
6 the family division of circuit court.

7       **(l)** ~~(k)~~—"Descendant" means, in relation to an individual, all  
8 of his or her descendants of all generations, with the relationship  
9 of parent and child at each generation being determined by the  
10 definitions of child and parent contained in this act.

11       **(m)** ~~(l)~~—"Devise" means, when used as a noun, a testamentary  
12 disposition of real or personal property and, when used as a verb,  
13 to dispose of real or personal property by will.

14       **(n)** ~~(m)~~—"Devisee" means a person designated in a will to  
15 receive a devise. For the purposes of article II, for a devise to a  
16 trustee of an existing trust or to a trustee under a will, the  
17 trustee is a devisee and a beneficiary is not.

18       **(o)** ~~(n)~~—"Disability" means cause for a protective order as  
19 described in section 5401.

20       **(p)** ~~(o)~~—"Distributee" means a person that receives a  
21 decedent's property from the decedent's personal representative or  
22 trust property from the trustee other than as a creditor or  
23 purchaser. A trustee of a trust created by will is a distributee  
24 only to the extent that distributed property or an increment of the  
25 distributed property remains in the trustee's hands. A beneficiary  
26 of a trust created by will to whom the trustee distributes property  
27 received from a personal representative is a distributee of the  
28 personal representative. For the purposes of this subdivision,  
29 "trustee of a trust created by will" includes a trustee to whom

1 property is transferred by will to the extent of the devised  
2 property.

3 (q) ~~(p)~~ "Do-not-resuscitate order" means that term as defined  
4 in section 2 of the Michigan do-not-resuscitate procedure act, 1996  
5 PA 193, MCL 333.1052.

6 Sec. 1106. As used in this act:

7 (a) "Mental health professional" means an individual who is  
8 trained and experienced in the area of mental illness or  
9 developmental disabilities and who is 1 of the following:

10 (i) A physician who is licensed to practice medicine or  
11 osteopathic medicine and surgery in this state under article 15 of  
12 the public health code, 1978 PA 368, MCL 333.16101 to 333.18838.

13 (ii) A psychologist licensed to practice in this state under  
14 article 15 of the public health code, 1978 PA 368, MCL 333.16101 to  
15 333.18838.

16 (iii) A registered professional nurse licensed to practice in  
17 this state under article 15 of the public health code, 1978 PA 368,  
18 MCL 333.16101 to 333.18838.

19 (iv) A licensed master's social worker licensed under article  
20 15 of the public health code, 1978 PA 368, MCL 333.16101 to  
21 333.18838.

22 (v) A physician's assistant licensed to practice in this state  
23 under article 15 of the public health code, 1978 PA 368, MCL  
24 333.16101 to 333.18838.

25 (vi) A licensed professional counselor licensed under part 181  
26 of the public health code, 1978 PA 368, MCL 333.18101 to 333.18117.

27 (b) "Michigan prudent investor rule" means the fiduciary  
28 investment and management rule prescribed by part 5 of this  
29 article.

1 (c) "Minor" means an individual who is less than 18 years of  
2 age.

3 (d) "Minor ward" means a minor for whom a guardian is  
4 appointed solely because of minority.

5 (e) "Money" means legal tender or a note, draft, certificate  
6 of deposit, stock, bond, check, or credit card.

7 (f) "Mortgage" means a conveyance, agreement, or arrangement  
8 in which property is encumbered or used as security.

9 (g) "Nonopioid directive form" means that term as defined in  
10 section 9145 of the public health code, 1978 PA 368, MCL 333.9145.

11 (h) "Nonresident decedent" means a decedent who was domiciled  
12 in another jurisdiction at the time of ~~his or her~~ **the decedent's**  
13 death.

14 (i) "Organization" means a corporation, business trust,  
15 estate, trust, partnership, limited liability company, association,  
16 or joint venture; governmental subdivision, agency, or  
17 instrumentality; public corporation; or another legal or commercial  
18 entity.

19 (j) "Parent" includes, but is not limited to, an individual  
20 entitled to take, or who would be entitled to take, as a parent  
21 under this act by intestate succession from a child who dies  
22 without a will and whose relationship is in question. Parent does  
23 not include an individual who is only a stepparent, foster parent,  
24 or grandparent.

25 (k) "Partial guardian" means that term as defined in section  
26 600 of the mental health code, 1974 PA 258, MCL 330.1600.

27 (l) "Patient advocate" means an individual designated to  
28 exercise powers concerning another individual's care, custody, and  
29 medical or mental health treatment or authorized to make an

1 anatomical gift on behalf of another individual, or both, as  
2 provided in section 5506.

3 (m) "Patient advocate designation" means the written document  
4 executed and with the effect as described in sections 5506 to 5515.

5 (n) "Payor" means a trustee, insurer, business entity,  
6 employer, government, governmental subdivision or agency, or other  
7 person authorized or obligated by law or a governing instrument to  
8 make payments.

9 (o) "Person" means an individual or an organization.

10 (p) "Personal representative" includes, but is not limited to,  
11 an executor, administrator, successor personal representative, and  
12 special personal representative, and any other person, other than a  
13 trustee of a trust subject to article VII, who performs  
14 substantially the same function under the law governing that  
15 person's status.

16 (q) "Petition" means a written request to the court for an  
17 order after notice.

18 (r) "Physician orders for scope of treatment form" means that  
19 term as defined in section 5674 of the public health code, 1978 PA  
20 368, MCL 333.5674.

21 (s) "Plenary guardian" means that term as defined in section  
22 600 of the mental health code, 1974 PA 258, MCL 330.1600.

23 **(t) "Power of appointment" means that term as defined in**  
24 **section 2 of the powers of appointment act of 1967, 1967 PA 224,**  
25 **MCL 556.112.**

26 (u) ~~(t)~~—"Proceeding" includes an application and a petition,  
27 and may be an action at law or a suit in equity. A proceeding may  
28 be denominated a civil action under court rules.

29 (v) ~~(u)~~—"Professional conservator" means a person that



1 provides conservatorship services for a fee. Professional  
 2 conservator does not include a person who is an individual who is  
 3 related to all but 2 of the protected individuals for whom he or  
 4 she is appointed as conservator.

5 (w) ~~(v)~~—"Professional guardian" means a person that provides  
 6 guardianship services for a fee. Professional guardian does not  
 7 include a person who is an individual who is related to all but 2  
 8 of the wards for whom he or she is appointed as guardian.

9 (x) ~~(w)~~—"Property" means anything that may be the subject of  
 10 ownership, and includes both real and personal property or an  
 11 interest in real or personal property.

12 (y) ~~(x)~~—"Protected individual" means a minor or other  
 13 individual for whom a conservator has been appointed or other  
 14 protective order has been made as provided in part 4 of article V.

15 (z) ~~(y)~~—"Protective proceeding" means a proceeding under ~~the~~  
 16 ~~provisions of~~ part 4 of article V.

17 Sec. 1210. (1) The specific dollar amounts stated in sections  
 18 2102, 2402, 2404, **and** 2405, and **the specific dollar amounts stated**  
 19 **in sections 3982 and 3983 before those sections were amended by the**  
 20 **amendatory act that added section 1215**, apply to decedents who die  
 21 before January 1, 2001. For decedents who die after December 31,  
 22 2000, these specific dollar amounts ~~shall~~**must** be multiplied by the  
 23 **1997** cost-of-living adjustment factor for the calendar year in  
 24 which the decedent dies.

25 (2) **Before January 1, 2024, the specific amounts stated in**  
 26 **sections 2519, 3605, 3916, 3918, 3981, and 5102, and the specific**  
 27 **amounts stated in sections 3982 and 3983 as amended by the**  
 28 **amendatory act that added section 1215, apply to those sections.**  
 29 **Beginning January 1, 2024, those specific dollar amounts must be**

1 multiplied by the 2023 cost-of-living adjustment factor for the  
2 calendar year in which the decedent dies.

3 (3) ~~(2)~~ Before February 1, 2001, and annually after 2001, the  
4 department of treasury shall publish the cost-of-living adjustment  
5 factor to be applied to the specific dollar amounts referred to in  
6 ~~subsection~~ **subsections (1) and (2)** for decedents who die during  
7 that calendar year and in section 7414 for trusts the value of the  
8 property of which is insufficient to justify the cost of  
9 administration. A product resulting from application of the cost-  
10 of-living adjustment factor to a specific dollar amount ~~shall~~ **must**  
11 be rounded to the nearest \$1,000.00 amount.

12 **Sec. 1215. (1) Subject to subsection (2), a person has**  
13 **knowledge of a fact if 1 or more of the following apply:**

14 (a) The person has actual knowledge of it.

15 (b) The person has received a notice or notification of it.

16 (c) From all the facts and circumstances known to the person  
17 at the time in question, the person has reason to know it.

18 (2) An organization that conducts activities through employees  
19 has notice or knowledge of a fact only from the time the  
20 information was received by an employee having responsibility to  
21 act or from the time the information would have been brought to the  
22 employee's attention if the organization had exercised reasonable  
23 diligence. An organization exercises reasonable diligence if it  
24 maintains reasonable routines for communicating significant  
25 information to the employee having responsibility to act and there  
26 is reasonable compliance with the routines. Reasonable diligence  
27 does not require an employee of the organization to communicate  
28 information unless the communication is part of the individual's  
29 regular duties or the individual knows a matter that would be

1 materially affected by the information.

2           Sec. 1216. (1) Any part of a governing instrument that  
3 directly or indirectly makes a substantial gift to an attorney who  
4 drafted the governing instrument or a person related to the  
5 attorney who drafted the governing instrument is void unless the  
6 attorney who drafted the governing instrument or the person related  
7 to the attorney who drafted the governing instrument is related to  
8 the individual making the substantial gift.

9           (2) This section does not apply to a provision in a governing  
10 instrument appointing the attorney who drafted the governing  
11 instrument, or a person related to the attorney who drafted the  
12 governing instrument, as a fiduciary.

13           (3) A provision in a governing instrument purporting to waive  
14 or otherwise avoid the application of this section is  
15 unenforceable.

16           (4) If a purchaser or lender for value acquires property  
17 distributed in kind or a security interest in property from a  
18 person that has received a substantial gift pursuant to a part of a  
19 governing instrument that is void under subsection (1), the  
20 purchaser or lender takes title free of any claims arising under,  
21 and incurs no personal liability by reason of, this section. This  
22 section does not directly or indirectly impose liability on a  
23 person that honors or relies on a part of a governing instrument  
24 that is void under subsection (1) and that contains or effectuates  
25 a substantial gift, unless the person has knowledge that the part  
26 of the governing instrument is void.

27           (5) If a part of a governing instrument is void under  
28 subsection (1), the part that is void is severable and does not  
29 affect any other part of the governing instrument that can be given

1 effect, including a term that makes an alternate or substitute  
2 gift. If the part of the governing instrument that is void under  
3 subsection (1) cannot be severed, the entire governing instrument  
4 is void. For a power of appointment, this section does not affect  
5 the power to appoint in favor of persons other than the attorney  
6 who drafted the governing instrument or a person related to the  
7 attorney who drafted the governing instrument.

8 (6) If the court determines that an attorney who drafted the  
9 governing instrument disguised or attempted to disguise a  
10 substantial gift, to the attorney who drafted the governing  
11 instrument or a person related to the attorney who drafted the  
12 governing instrument, as a conveyance for consideration for less  
13 than fair market value, the court may find the conveyance void  
14 under subsection (1).

15 (7) The rights and remedies granted in this section are in  
16 addition to any other rights or remedies a person may have at law.  
17 A part of a governing instrument that is not void under subsection  
18 (1) may be challenged under other legal grounds.

19 (8) This section applies only to a governing instrument  
20 executed after the effective date of the amendatory act that added  
21 this section.

22 (9) For purposes of this section, a person is related to an  
23 individual if, at the time the attorney who drafted the governing  
24 instrument prepared or supervised the preparation or execution of  
25 the governing instrument, the person is any of the following:

26 (a) A spouse of the individual.

27 (b) A lineal ascendant or descendant of the individual or the  
28 individual's spouse.

29 (c) A sibling of the individual.

1 (d) A spouse of the individual described in subdivision (b) or  
2 (c).

3 (10) For purposes of this section, an organization is related  
4 to an attorney if the attorney owns a 50% or greater interest in  
5 the organization or otherwise controls the organization.

6 (11) As used in this section:

7 (a) "Attorney who drafted the governing instrument" means an  
8 individual to whom both of the following apply:

9 (i) The individual is or was licensed to practice law in this  
10 state or any other state, before or at the time the governing  
11 instrument was prepared or executed, or both.

12 (ii) The individual directly or indirectly prepared or  
13 supervised the preparation, execution, or both, of the governing  
14 instrument. For purposes of this subparagraph, among other ways,  
15 the individual is considered to have prepared, or supervised the  
16 execution of, the governing instrument if the preparation, or  
17 supervision of the execution, of the governing instrument was  
18 performed by an employee, subordinate, partner, co-owner, or other  
19 person or lawyer employed by the same firm or company as the  
20 individual as of the time of preparation or execution, or both.

21 (b) "Gift" includes an inter vivos gift, a testamentary  
22 transfer of property, and the power to make the testamentary  
23 transfer regardless of any of the following:

24 (i) Whether the gift or testamentary transfer is outright or in  
25 trust.

26 (ii) When the gift or testamentary transfer is to take effect.

27 (iii) Whether the power is held in a fiduciary or nonfiduciary  
28 capacity.

29 (c) "Substantial gift" means a gift, the value of which

1 **exceeds \$5,000.00 as a result of a single governing instrument or 2**  
 2 **or more related governing instruments.**

3       Sec. 2519. (1) A will executed in the form prescribed by  
 4 subsection (2) and otherwise in compliance with the terms of the  
 5 Michigan statutory will form is a valid will. A person printing and  
 6 distributing the Michigan statutory will shall print and distribute  
 7 the form verbatim as it appears in subsection (2). The notice  
 8 provisions must be printed in 10-point boldfaced type.

9       (2) The form of the Michigan statutory will is as follows:

10                                   MICHIGAN STATUTORY WILL NOTICE

11       1. An individual age 18 or older who has sufficient mental  
 12 capacity may make a will.

13       2. There are several kinds of wills. If you choose to complete  
 14 this form, you will have a Michigan statutory will. If this will  
 15 does not meet your wishes in any way, you should talk with a lawyer  
 16 before choosing a Michigan statutory will.

17       3. Warning! It is strongly recommended that you do not add or  
 18 cross out any words on this form except for filling in the blanks  
 19 because all or part of this will may not be valid if you do so.

20       4. This will has no effect on jointly held assets, on  
 21 retirement plan benefits, or on life insurance on your life if you  
 22 have named a beneficiary who survives you.

23       5. This will is not designed to reduce estate taxes.

24       6. This will treats adopted children and children born outside  
 25 of wedlock who would inherit if their parent died without a will  
 26 the same way as children born or conceived during marriage.

27       7. You should keep this will in your safe deposit box or other  
 28 safe place. By paying a small fee, you may file this will in your  
 29 county's probate court for safekeeping. You should tell your family

17 The following definitions and rules of construction apply to

14 **will or other writing** becomes effective when, after having given 7  
15 days' prior written notice of intention to do so to the legally  
16 incapacitated individual and to the person having care of the

18 the guardian files acceptance of appointment in the court in which  
19 the will containing the nomination is probated or, if the

5 court at the place where the legally incapacitated individual  
6 resides or is present, the appointment is terminated. An objection

11 **Sec. 5301c. (1) At a hearing convened under this part, the**  
12 **court may designate 1 or more standby guardians. The court may**

3 (e) Informing the individual that if a guardian is appointed,  
4 the guardian may have the power to execute a physician orders for  
5 scope of treatment form on behalf of the individual and, if  
6 meaningful communication is possible, discern if the individual  
7 objects to having a physician orders for scope of treatment form  
8 executed on ~~his or her~~ **the individual's** behalf.

9 (f) Informing the individual of the name of each person known  
10 to be seeking appointment as guardian **or designation as standby**  
11 **guardian.**

12 (g) Asking the individual and the petitioner about the amount  
13 of cash and property readily convertible into cash that is in the  
14 individual's estate.

15 (h) Making determinations, and informing the court of those  
16 determinations, on all of the following:

17 (i) Whether there are 1 or more appropriate alternatives to the  
18 appointment of a full guardian or whether 1 or more actions should  
19 be taken in addition to the appointment of a guardian. Before  
20 informing the court of ~~his or her~~ **the guardian ad litem's**  
21 determination under this subparagraph, the guardian ad litem shall  
22 consider the appropriateness of at least each of the following as

13 (v) Whether the individual wishes limits placed on the  
14 guardian's powers.

15 (vi) Whether the individual objects to having a do-not-  
16 resuscitate order executed on ~~his or her~~ **the individual's** behalf.

17 (vii) Whether the individual objects to having a physician  
18 orders for scope of treatment form executed on ~~his or her~~ **the**  
19 **individual's** behalf.

20 (viii) Whether the individual objects to a particular person  
21 being appointed guardian **or designated a standby guardian.**

22 (2) The court shall not order compensation of the guardian ad  
23 litem unless the guardian ad litem states on the record or in the

26 (3) If the individual alleged to be incapacitated wishes to  
27 contest the petition, to have limits placed on the guardian's  
28 powers, or to object to a particular person being appointed

20 (s) To a guardianship designed to encourage the development of  
21 maximum self-reliance and independence as provided in section 5306.

22 (t) To prevent the grant of powers to a guardian if those  
23 powers are already held by a valid patient advocate, as provided in  
24 section 5306.

25 (u) To periodic review of the guardianship by the court,  
26 including the right to a hearing and the appointment of an attorney  
27 if issues arise upon the review of the guardianship, as provided in  
28 section 5309.

29 (v) To, at any time, seek modification or termination of the

1 guardianship by informal letter to the judge, as provided in  
2 section 5310.

3 (w) To a hearing within 28 days of requesting a review,  
4 modification, or termination of the guardianship, as provided in  
5 section 5310.

6 (x) To the same rights on a petition for modification or  
7 termination of the guardianship including the appointment of a  
8 visitor as apply to a petition for appointment of a guardian, as  
9 provided in section 5310.

10 (y) To personal notice of a petition for appointment or  
11 removal of a guardian **or the designation or change in designation**  
12 **of a standby guardian**, as provided in section 5311.

13 (z) To written notice of the nature, purpose, and legal  
14 effects of the appointment of a guardian, as provided in section  
15 5311.

16 (aa) To choose the person who will serve as guardian **and the**  
17 **person designated as standby guardian**, if the chosen person is  
18 suitable and willing to serve, as provided in ~~section~~**sections** 5313  
19 **and 5301c, as applicable.**

20 (bb) To consult with the guardian about major decisions  
21 affecting the individual, if meaningful conversation is possible,  
22 as provided in section 5314.

23 (cc) To quarterly visits by the guardian, as provided in  
24 section 5314.

25 (dd) To have the guardian notify the court within 14 days of a  
26 change in the individual's residence, as provided in section 5314.

27 (ee) To have the guardian secure services to restore the  
28 individual to the best possible state of mental and physical well-  
29 being so that the individual can return to self-management at the

1 earliest possible time, as provided in section 5314.

2 (ff) To have the guardian take reasonable care of the  
3 individual's clothing, furniture, vehicles, and other personal  
4 effects, as provided in section 5314.

5 (2) A guardian ad litem shall inform the ward in writing of  
6 ~~his or her~~ **the ward's** rights enumerated in this section. The state  
7 court administrative office and the ~~office of services to the aging~~  
8 ~~created in section 5 of the older Michiganians act, 1981 PA 180,~~  
9 ~~MCL 400.585,~~ **health and aging services administration created under**  
10 **Executive Reorganization Order No. 2021-2, MCL 400.562,** shall  
11 promulgate a form to be used to give the written notice under this

9 (4) If none of the persons as designated or listed in  
10 subsection (2) or (3) are suitable or willing to serve, the court  
11 may appoint any competent person who is suitable and willing to  
12 serve, including a professional guardian as provided in section  
13 5106.

14 Sec. 5314. If meaningful communication is possible, a legally  
15 incapacitated individual's guardian shall consult with the legally  
16 incapacitated individual before making a major decision affecting  
17 the legally incapacitated individual. To the extent a guardian of a  
18 legally incapacitated individual is granted powers by the court  
19 under section 5306, the guardian is responsible for the ward's  
20 care, custody, and control, but is not liable to third persons  
21 because of that responsibility for the ward's acts. In particular  
22 and without qualifying the previous sentences, a guardian has all

26 establish the ward's place of residence in or outside this state.  
27 The guardian shall visit the ward within 3 months after the  
28 guardian's appointment and not less than once within 3 months after  
29 each previous visit. The guardian shall notify the court within 14

1 days of a change in the ward's place of residence or a change in  
2 the guardian's place of residence.

3 (b) If entitled to custody of the ward, the duty to make  
4 provision for the ward's care, comfort, and maintenance and, when  
5 appropriate, arrange for the ward's training and education. The  
6 guardian shall secure services to restore the ward to the best  
7 possible state of mental and physical well-being so that the ward  
8 can return to self-management at the earliest possible time.  
9 Without regard to custodial rights of the ward's person, the  
10 guardian shall take reasonable care of the ward's clothing,  
11 furniture, vehicles, and other personal effects and commence a  
12 protective proceeding if the ward's other property needs  
13 protection. If a guardian commences a protective proceeding because  
14 the guardian believes that it is in the ward's best interest to  
15 sell or otherwise dispose of the ward's real property or interest  
16 in real property, the court may appoint the guardian as special  
17 conservator and authorize the special conservator to proceed under  
18 section 5423(3). A guardian shall not otherwise sell the ward's  
19 real property or interest in real property.

20 (c) The power to give the consent or approval that is  
21 necessary to enable the ward to receive medical, mental health, or  
22 other professional care, counsel, treatment, or service. However, a  
23 guardian does not have and shall not exercise the power to give the  
24 consent to or approval for inpatient hospitalization unless the  
25 court expressly grants the power in its order. If the ward objects  
26 or actively refuses mental health treatment, the guardian or any  
27 other interested person must follow the procedures provided in

10 (d) The power to execute, reaffirm, and revoke a do-not-  
11 resuscitate order on behalf of a ward. However, a guardian shall  
12 not execute a do-not-resuscitate order unless the guardian does all  
13 of the following:

14 (i) Not more than 14 days before executing the do-not-  
15 resuscitate order, visits the ward and, if meaningful communication  
16 is possible, consults with the ward about executing the do-not-  
17 resuscitate order.

18 (ii) Consults directly with the ward's attending physician as  
19 to the specific medical indications that warrant the do-not-  
20 resuscitate order.

21 (e) If a guardian executes a do-not-resuscitate order under  
22 subdivision (d), not less than annually after the do-not-  
23 resuscitate order is first executed, the duty to do all of the  
24 following:

25 (i) Visit the ward and, if meaningful communication is  
26 possible, consult with the ward about reaffirming the do-not-  
27 resuscitate order.

28 (ii) Consult directly with the ward's attending physician as to  
29 specific medical indications that may warrant reaffirming the do-

1 not-resuscitate order.

2 (f) The power to execute, reaffirm, and revoke a nonopioid  
3 directive form on behalf of a ward.

4 (g) The power to execute, reaffirm, and revoke a physician  
5 orders for scope of treatment form on behalf of a ward. However, a  
6 guardian shall not execute a physician orders for scope of  
7 treatment form unless the guardian does all of the following:

8 (i) Not more than 14 days before executing the physician orders  
9 for scope of treatment form, visits the ward and, if meaningful  
10 communication is possible, consults with the ward about executing  
11 the physician orders for scope of treatment form.

12 (ii) Consults directly with the ward's attending physician as  
13 to the specific medical indications that warrant the physician  
14 orders for scope of treatment form.

15 (h) If a guardian executes a physician orders for scope of  
16 treatment form under subdivision ~~(f)~~, **(g)**, not less than annually  
17 after the physician orders for scope of treatment **form** is first  
18 executed, the duty to do all of the following:

19 (i) Visit the ward and, if meaningful communication is  
20 possible, consult with the ward about reaffirming the physician  
21 orders for scope of treatment form.

22 (ii) Consult directly with the ward's attending physician as to  
23 specific medical indications that may warrant reaffirming the  
24 physician orders for scope of treatment form.

25 (i) If a conservator for the ward's estate is not appointed,  
26 the power to do any of the following:

27 (i) Institute a proceeding to compel a person under a duty to  
28 support the ward or to pay money for the ward's welfare to perform  
29 that duty.

1           (ii) Receive money and tangible property deliverable to the  
2 ward and apply the money and property for the ward's support, care,  
3 and education. The guardian shall not use money from the ward's  
4 estate for room and board that the guardian or the guardian's  
5 spouse, parent, or child have furnished the ward unless a charge  
6 for the service is approved by court order made on notice to at  
7 least 1 of the ward's next of kin, if notice is possible. The  
8 guardian shall exercise care to conserve any excess for the ward's  
9 needs.

10           (j) The duty to report the condition of the ward and the  
11 ward's estate that is subject to the guardian's possession or  
12 control, as required by the court, but not less often than  
13 annually. The guardian shall also serve the report required under  
14 this subdivision on the ward and interested persons as specified in  
15 the Michigan court rules. A report under this subdivision must  
16 contain all of the following:

17           (i) The ward's current mental, physical, and social condition.

18           (ii) Improvement or deterioration in the ward's mental,  
19 physical, and social condition that occurred during the past year.

28 a do-not-resuscitate order on behalf of the ward during the past  
29 year.

1           (vii) Whether the guardian has executed, reaffirmed, or revoked  
2 a nonopioid directive form on behalf of the ward during the past  
3 year.

4           (viii) Whether the guardian has executed, reaffirmed, or revoked  
5 a physician orders for scope of treatment form on behalf of the  
6 ward during the past year.

7           (ix) Services received by the ward.

8           (x) A list of the guardian's visits with, and activities on  
9 behalf of, the ward.

10          (xi) A recommendation as to the need for continued  
11 guardianship.

12          **(xii) If a standby guardian has been designated, a statement**  
13 **signed by the standby guardian that the standby guardian continues**  
14 **to be willing to serve in the event of the unavailability, death,**  
15 **incapacity, or resignation of the guardian.**

16          (k) If a conservator is appointed, the duty to pay to the  
17 conservator, for management as provided in this act, the amount of  
18 the ward's estate received by the guardian in excess of the amount  
19 the guardian expends for the ward's current support, care, and  
20 education. The guardian shall account to the conservator for the  
21 amount expended.

22          Sec. 5507. (1) A patient advocate designation may include a  
23 statement of the patient's desires on care, custody, and medical  
24 treatment or mental health treatment, or both. A patient advocate  
25 designation may also include a statement of the patient's desires  
26 on the making of an anatomical gift of all or part of the patient's

20 5. A patient advocate shall not receive compensation for the  
21 performance of ~~his or her~~ **the patient advocate's** authority, rights,

23 actual and necessary expenses incurred in the performance of ~~his or~~

6 8. A patient may waive ~~his or her~~ **the patient's** right to  
7 revoke the patient advocate designation as to the power to make  
8 mental health treatment decisions, and if ~~such a~~ **the** waiver is  
9 made, ~~his or her~~ **the patient's** ability to revoke as to certain  
10 treatment will be delayed for 30 days after the patient  
11 communicates ~~his or her~~ **the patient's** intent to revoke.

12 9. A patient advocate may revoke ~~his or her~~ **the patient**  
13 **advocate's** acceptance of the patient advocate designation at any  
14 time and in any manner sufficient to communicate an intent to  
15 revoke.

16 10. A patient admitted to a health facility or agency has the  
17 rights enumerated in section 20201 of the public health code, 1978  
18 PA 368, MCL 333.20201.

19 Sec. 7103. As used in this article:

20 (a) "Action", with respect to a trustee, includes an act or a  
21 failure to act.

22 (b) "Ascertainable standard" means a standard relating to an  
23 individual's health, education, support, or maintenance within the

5 import, to determine 1 or more of the following:
