

SUBSTITUTE FOR
HOUSE BILL NO. 4930

A bill to amend 1990 PA 187, entitled
"The pupil transportation act,"
by amending sections 5 and 20 (MCL 257.1805 and 257.1820), section
5 as amended by 2006 PA 107 and section 20 as added by 2021 PA 52.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 5. (1) **"Law enforcement agency" means that term as**
2 **defined in section 682 of the Michigan vehicle code, 1949 PA 300,**
3 **MCL 257.682.**

4 (2) **"Motor bus" means bus** and "motor carrier of passengers"
5 ~~mean~~**means motor carrier as** those terms ~~as~~**are** defined in section 3
6 of the motor bus transportation act, 1982 PA 432, MCL 474.103.

7 (3) ~~(2)~~**"Nonpublic school" means that term as defined in**
8 section 5 of the revised school code, 1976 PA 451, MCL 380.5.

1 (4) ~~(3)~~—"Public school" means that term as defined in section
2 5 of the revised school code, 1976 PA 451, MCL 380.5.

3 (5) ~~(4)~~—"Rule" means a rule promulgated pursuant to the
4 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
5 24.328.

6 (6) ~~(5)~~—"School" means either a public school or a nonpublic
7 school, or both.

8 (7) "School district" means that term as defined in section 6
9 of the revised school code, 1976 PA 451, MCL 380.6.

10 (8) "Stop-arm camera system" means a system of 2 or more
11 cameras affixed to a school bus that meets all of the following
12 requirements:

13 (a) Is synchronized to automatically record video or 1 or more
14 sequenced photographs of a vehicle that fails to stop for a school
15 bus or passes a school bus in violation of section 682(1) of the
16 Michigan vehicle code, 1949 PA 300, MCL 257.682.

17 (b) Is capable of capturing images of both of the following:

18 (i) The vehicle.

19 (ii) The registration plate on the rear of the vehicle.

20 (c) Records the date, time, and location on a video recorded
21 or photograph captured by the system.

22 Sec. 20. (1) A school bus may be equipped with a stop-arm
23 camera system in accordance with this section.

24 (2) A school **district** may do ~~either~~ **any** of the following:

25 (a) Install and operate a stop-arm camera system on a school
26 bus.

27 (b) Enter into an agreement with 1 or more law enforcement
28 agencies that establishes enforcement responsibilities for and the
29 reimbursement of any costs related to a camera-based violation of

1 section 682(1) of the Michigan vehicle code, 1949 PA 300, MCL
2 257.682.

3 (c) ~~(b)~~ Enter into a contract with a private vendor to install
4 and do 1 or more of the following:

5 (i) Install, operate, and provide support to a stop-arm camera
6 system on a school bus.

7 ~~(3) As used in this section, "stop-arm camera system" means a~~
8 ~~system of 2 or more cameras affixed to a school bus that meets all~~
9 ~~of the following requirements:~~

10 ~~(a) Is synchronized to automatically record video or 1 or more~~
11 ~~sequenced photographs of a vehicle failing to stop for a school bus~~
12 ~~or passing a school bus in violation of section 682(1) of the~~
13 ~~Michigan vehicle code, 1949 PA 300, MCL 257.682.~~

14 ~~(b) Is capable of capturing images of all of the following:~~

15 ~~(i) The vehicle.~~

16 ~~(ii) The registration plate on the rear of the vehicle.~~

17 ~~(iii) A distance of not less than 200 feet in front of the~~
18 ~~school bus.~~

19 ~~(c) Records the date, time, and location on an image produced~~
20 ~~by the system.~~

21 (ii) Perform the school district's obligations under an
22 agreement described in subdivision (b) on behalf of the school
23 district.

24 (3) If required by a contract entered into under subsection
25 (2), a private vendor operating a stop-arm camera system shall
26 provide all of the following information to a law enforcement
27 agency authorized to enforce section 682(1) of the Michigan vehicle
28 code, 1949 PA 300, MCL 257.682, if the stop-arm camera system
29 captures a photograph or records video showing an alleged violation

1 of section 682(1) of the Michigan vehicle code, 1949 PA 300, MCL
2 257.682:

3 (a) A copy of the photograph captured or video recorded
4 showing the motor vehicle.

5 (b) The registration plate number and state of issuance of the
6 registration plate.

7 (c) The date, time, and place of the alleged violation.

8 Enacting section 1. This amendatory act does not take effect
9 unless all of the following bills of the 102nd Legislature are
10 enacted into law:
