## **HOUSE BILL NO. 5269**

October 26, 2023, Introduced by Reps. Koleszar, Glanville, Weiss and Conlin and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 504a, 506, 525, 527, 557, 560, 1311h, and 1311k (MCL 380.504a, 380.506, 380.525, 380.527, 380.557, 380.560, 380.1311h, and 380.1311k), section 504a as amended and sections 525 and 527 as added by 2003 PA 179, section 506 as added by 1993 PA 362, sections 557 and 560 as added by 2009 PA 205, section 1311h as amended by 2012 PA 620, and section 1311k as added by 1999 PA 23.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 504a. In addition to other powers set forth in this part,

- 11 general funds or any other money available for such a purpose.
- 12 Bonds issued under this section are subject to the revised
- 13 municipal finance act, 2001 PA 34, MCL 141.2101 to 141.2821.
- 14 Sec. 527. (1) An urban high school academy, with the approval
- 15 of the authorizing body, may employ or contract with personnel, or
- 16 enter into a contract with another party to furnish teachers or
- 17 other personnel, as necessary for the operation of the urban high
- 18 school academy, prescribe their the personnel's duties, and fix
- 19 their the personnel's compensation.
- 20 (2) By not later than November 1 of each year, each urban high
- 21 school academy shall post all of the following information on its
- 22 website that is accessible to the public:
- 23 (a) The average salary for new teachers and the average salary
- 24 for veteran teachers employed by the urban high school academy or
- 25 employed by an educational management organization and assigned to
- 26 the urban high school academy, or, if there are fewer than 5 new
- 27 teachers or 5 veteran teachers at the urban high school academy,

- 20 (b) Subject to section 555, to acquire, hold, and own in its
- 21 own name real and personal property, or interests in real or
- 22 personal property, for educational purposes by purchase, gift,
- 23 grant, devise, bequest, lease, sublease, installment purchase
- 24 agreement, land contract, option, or condemnation, and subject to
- 25 mortgages, security interests, or other liens; and to sell or
- 26 convey the property as the interests of the school of excellence
- 27 require.
- 28 (c) To receive, disburse, and pledge funds for lawful
- 29 purposes.

- 1 (d) To enter into binding legal agreements with persons or 2 entities as necessary for the operation, management, financing, and 3 maintenance of the school of excellence, if the agreement is in 4 compliance with sections 7 and 18 of the state school aid act of 5 1979, MCL 388.1607 and 388.1618.
- 6 (e) To incur temporary debt in accordance with section 1225.
- 7 (f) To solicit and accept any grants or gifts for educational 8 purposes and to establish or permit to be established on its behalf 9 1 or more nonprofit corporations the purpose of which is to assist 10 the school of excellence in the furtherance of its public purposes.

  - (f) "Veteran teacher" means an individual who has held a teaching certificate for 5 or more years.
