## HOUSE SUBSTITUTE FOR SENATE BILL NO. 752

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

by amending sections 236 and 241 (MCL 388.1836 and 388.1841), section 236 as amended by 2023 PA 320 and section 241 as amended by 2023 PA 103.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 236.  $\frac{(1)}{}$  Subject to the conditions set forth in this

MCL 38.1301 to 38.1437, and that pay contributions to the Michigan 1 2 public school employees' retirement system for the state fiscal 3 <del>vear.</del> 4 (10) For fiscal year 2023-2024 only, from the appropriations described in subsection (1), the amount appropriated for Michigan 5 6 Technological University for the creation of a bachelor of science 7 degree in nursing program is \$870,000.00, appropriated from state 8 general fund/general purpose money. 9 (11) For fiscal year 2023-2024 only, from the appropriations 10 described in subsection (1), \$3,000,000.00 is appropriated from 11 state general fund/general purpose money to the Michigan geological 12 survey for costs related to the development, construction, and equipment purchases for a new facility. 13 14 (12) For fiscal year 2023-2024 only, from the appropriations 15 described in subsection (1), \$5,000,000.00 is appropriated from 16 state general fund/general purpose money for critical incident 17 mapping. These funds must be distributed to universities 18 proportionately to the amounts in subsection (2) for operations. 19 (13) For fiscal year 2023-2024 only, from the appropriations 20 described in subsection (1), subject to sections 236m and 236o, 21 \$79,000,000.00 is appropriated from general fund/general purpose 22 money for infrastructure, technology, equipment, maintenance, and 23 safety. 24 (14) For fiscal year 2023-2024 only, from the appropriations described in subsection (1), \$30,000,000.00 is appropriated from 25 the state school aid fund to Michigan State University for the 26 27 Engineering and Digital Innovation Center. Sec. 241. Subject to sections 241a, 241b, 241c, and 244, the 28 29 funds appropriated in section 236 to public universities must be

- 1 paid out of the state treasury and distributed by the state
- 2 treasurer to the respective institutions in 11 equal monthly
- 3 installments on the sixteenth of each month, or the next succeeding
- 4 business day, beginning with October 16, 2023. 2024. Except for
- 5 Wayne State University, each institution shall accrue its July and
- 6 August 2024 2025 payments to its institutional fiscal year ending
- 7 June 30, <del>2024.</del>**2025**.
