A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 3406z.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3406z. (1) A health insurance policy delivered, issued
- 2 for delivery, or renewed in this state that provides coverage for
- 3 prescribed orally administered anticancer medications and
- 4 intravenously administered or injected anticancer medications must
- 5 ensure either of the following:
- 6 (a) That financial requirements applicable to prescribed

- 1 orally administered anticancer medications are not more restrictive
- 2 than the financial requirements that apply to intravenously
- 3 administered or injected anticancer medications that are covered by
- 4 the health insurance policy.
- 5 (b) That the co-pay or coinsurance for orally administered
- 6 anticancer medication does not exceed \$150.00 per 30-day supply.
- 7 Beginning January 1, 2025, and each January 1 after that date, the
- 8 department shall adjust the financial requirement described in this
- 9 subdivision by an amount determined by the state treasurer that
- 10 reflects the cumulative annual change in the prescription drug
- 11 index of the medical care component of the United States Consumer
- 12 Price Index.
- 13 (2) An insurer cannot achieve compliance with this section by
- 14 increasing cost-sharing requirements, reclassifying benefits with
- 15 respect to anticancer medications, or imposing more restrictive
- 16 treatment limitations on prescribed orally administered anticancer
- 17 medications or intravenously administered or injected anticancer
- 18 medications covered under a health insurance policy described in
- 19 subsection (1).
- 20 (3) This section does not prohibit an insurer from applying
- 21 utilization management techniques, including prior authorization,
- 22 step therapy, limits on quantity dispensed, and days' supply per
- 23 fill for any administered anticancer medication.
- 24 (4) As used in this section:
- 25 (a) "Anticancer medication" means a medication used to kill,
- 26 slow, or prevent the growth of cancerous cells.
- 27 (b) "Cost-sharing requirement" means deductibles, copayments,
- 28 coinsurance, out-of-pocket expenses, aggregate lifetime limits, and
- 29 annual limits.

- 1 (c) "Treatment limitation" means limits on the frequency of 2 treatment, days of coverage, or other similar limits on the scope 3 or duration of treatment. Treatment limitation does not include the 4 application of utilization management techniques described in 5 subsection (3).
- Enacting section 1. This amendatory act applies to health
 insurance policies delivered, issued for delivery, or renewed in
 this state after December 31, 2023.
