## **HOUSE BILL NO. 5278**

October 26, 2023, Introduced by Reps. Bezotte, Miller, Mentzer, Martus, MacDonell, Price, Glanville, DeBoer, Wozniak, Hill, Koleszar, Schmaltz, Edwards, Coffia, Tsernoglou, Arbit, Brenda Carter, Rogers and Bruck and referred to the Committee on Military, Veterans and Homeland Security.

A bill to amend 1953 PA 192, entitled

"An act to create a county department of veterans' affairs in certain counties, and to prescribe its powers and duties; to create the county veteran service fund and to provide for contributions to and expenditures from that fund; and to transfer the powers and duties of the soldiers' relief commission in those counties,"

(MCL 35.621 to 35.624) by amending the title, as amended by 2018 PA 210, and by adding section 3b.

- 19 (3) The agency shall offer retraining either yearly or every

- 24 Rating Scale or Mini International Neuropsychiatric Interview and

- 1 substance abuse screening information on additional indicators and
- 2 contact information for reaching out for assistance after the
- 3 mental health and substance abuse screening has been conducted.
- 4 (d) Provide a written screening report.
- 5 (e) Include a disclaimer that the mental health and substance
- 6 abuse screening is intended to be purely informational and is not
- 7 considered a replacement for a full evaluation by a licensed health
- 8 care professional.
- 9 (5) The agency must provide a veteran who undergoes a mental
- 10 health and substance abuse screening described in this section a
- 11 copy of the screening report, on request, and retain the screening
- 12 report for 2 years. A copy of the screening report of a veteran may
- 13 be provided to a medical or behavioral health professional outside
- 14 the mental health and substance abuse screening process only on the
- 15 written release of that veteran.
- 16 (6) The agency shall implement a data collection policy that
- 17 informs the agency where and how often the mental health and
- 18 substance abuse screenings are conducted and how often the mental
- 19 health and substance abuse screenings lead to additional referrals.
- 20 The data collected must not contain any personal health identifying
- 21 information.
- 22 (7) A screening report prepared under this section is not
- 23 subject to disclosure under the freedom of information act, 1976 PA
- 24 442, MCL 15.231 to 15.246.
- 25 (8) As used in this section:
- 26 (a) "Agency" means the Michigan veterans affairs agency.
- 27 (b) "Department" means the department of military and veterans
