HOUSE BILL NO. 5874

June 27, 2024, Introduced by Reps. Mentzer, Brixie, Arbit, McFall and Hood and referred to the Committee on Natural Resources, Environment, Tourism and Outdoor Recreation.

A bill to provide for the responsibilities of the department of natural resources, the state historic preservation office, and other state agencies concerning archaeology, Native American cultural items, and certain discoveries of human remains.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Department" means the department of natural resources.
- 3 (b) "SHPO" means the state historic preservation office of the4 Michigan economic development corporation.
- 5 Sec. 3. The department shall do all of the following:

- 25 Sec. 9. The department and state government archaeologists

- 3 (c) Provide advice regarding archaeological site discovery and
- 4 private artifact collections.
- 5 (d) Provide archaeological technical assistance, information,

- 7 (e) Serve as contacts for the public for inadvertent
- 8 discoveries of archaeological resources or cultural artifacts on
- 9 private land.
- 10 (f) Provide education, interpretation, and outreach about
- 11 Michigan archaeology.
- 12 Sec. 11. Within 60 days after the effective date of this act,
- 13 state departments shall update all relevant information
- 14 disseminated to the public, Native American tribes, organizations,
- 15 and local, state, and federal partners so that it is consistent
- 16 with this act.
- 17 Sec. 13. This act does not apply to any location,
- 18 archaeological resource, or archaeological activity under the
- 19 jurisdiction of the Mackinac Island state park commission.
