November 26, 2024, Introduced by Rep. Farhat and referred to the Committee on Economic Development and Small Business.

A bill to amend 1965 PA 203, entitled "Michigan commission on law enforcement standards act," by amending section 2 (MCL 28.602), as amended by 2021 PA 42.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

 17 this state. This subdivision does not include an individual
 18 employed solely because he or she the individual occupies any other
- 19 office or position.
- 20 (B) An individual employed as a Michigan tribal law
 21 enforcement officer by a federally recognized Indian tribe that has
 22 trust lands located within this state, subject to a written
 23 instrument authorizing the individual to enforce the laws of this
 24 state.
- 25 (C) The sergeant at arms or any assistant sergeant at arms of either house of the legislature who is commissioned as a police officer by that respective house of the legislature as provided by the legislative sergeant at arms police powers act, 2001 PA 185, MCL 4.381 to 4.382.
