

# SENATE RESOLUTION NO. 60

Senator Moss offered the following resolution:

1 A resolution to recognize June 2023 as Lesbian, Gay, Bisexual,  
2 Transgender, Queer+ (LGBTQ+) Pride Month.

3 Whereas, Pride began in 1970 with the one year anniversary of  
4 the Stonewall Riots, a multi-day protest that is credited by many  
5 for starting the modern-day LGBTQ+ movement. In 1969, LGBTQ+  
6 individuals, led by the efforts of Black and Brown trans women such  
7 as activists Marsha P. Johnson and Sylvia Rivera, risked their  
8 lives to protest the over-policing and injustice that threatened  
9 their existence on a daily basis, and elevated the visibility of  
10 the movement to a national scale; and

11 Whereas, The LGBTQ+ community has persevered through tragedies  
12 and struggles, such as the government's insufficient and delayed

1 response to assisting those with HIV/AIDS and the ongoing effort to  
2 protect the rights and ensure the safety of the LGBTQ+ community;  
3 and

4       Whereas, The movement has also celebrated victories of  
5 recognition, especially the historic *Obergefell v. Hodges* decision  
6 in 2015 which recognized marriage equality nationwide, the *Bostock*  
7 *v. Clayton County* decision in 2020 that upheld federal employment  
8 protections for the LGBTQ+ community, and *Rouch World v. Department*  
9 *of Civil Rights* in 2022 that affirmed LGBTQ+ protections are  
10 included in Michigan's Elliott-Larsen Civil Rights Act; and

11       Whereas, After a fifty year legislative effort, the Michigan  
12 House and Senate in its 102nd Legislature, at long last, added  
13 sexual orientation and gender identity or expression as protected  
14 classes in the Elliott-Larsen Civil Rights Act, which was signed  
15 into law as Public Act 6 of 2023; and

16       Whereas, Still today, LGBTQ+ individuals, especially a  
17 disproportionate number of trans women of color, continue to be a  
18 target of harassment, violence, and discrimination, yet through  
19 community support and solidarity continue to celebrate love,  
20 authentic living, and self-acceptance; and

21       Whereas, Michigan stands out in this watershed moment as a  
22 state that embraces equality because our communities benefit from  
23 diversity and variety in viewpoints, talents, and cultural  
24 perspectives of its residents and from preserving the freedom,  
25 worth, and dignity of those in the LGBTQ+ community; and

26       Whereas, Michigan should expend all efforts to attract and  
27 retain talent and signal to the nation we are welcoming to all  
28 those who wish to contribute to the economic vitality of our state;  
29 and

1           Whereas, The people of Michigan understand, appreciate, and  
2 value the cultural, civic, and economic contributions of the LGBTQ+  
3 community to the larger success of the state, and commit to the  
4 learning, humility, and work necessary to make the state fair,  
5 safe, equitable, and a refuge of stability regardless of sexual  
6 orientation, gender identity, or expression; and

7           Whereas, June is recognized and celebrated as LGBTQ+ Pride  
8 Month throughout the country and worldwide; now, therefore, be it

9           Resolved by the Senate, That the members of this legislative  
10 body recognize June 2023 as Lesbian, Gay, Bisexual, Transgender,  
11 Queer+ (LGBTQ+) Pride Month.
