Major Boilerplate Changes from FY 2024-25 Year-to-Date:

1. Senate recommended the continuation of most sections of FY 2024-25 boilerplate. They include prohibiting employee discipline for communication with legislature (Sec. 206), priority of spending down work projects (Sec. 222), notification of intent to close or consolidate an MSP post (Sec. 226), notice of intent to privatize (Sec. 227), ensures privacy of personal data (Sec. 233), prohibits ticket quotas (Sec. 234), allows Director to establish local headquarters (Sec. 237), spending down of ARP funds (Sec. 239), grant disbursements/awards transparency guidelines (Sec. 250), and a statement of goals and performance metrics for criminal investigations (Sec. 602), and retains sections dealing with department performance objectives and metrics. Senate included language covering guides for appropriations for DECF deposit (Sec. 801), law enforcement communications training (Sec.802), cold case investigations (Sec.803), public safety academy assistance program (Sec.804), public safety heroes program (Sec.805), and statewide fentanyl enforcement (Sec.807), eliminates the cap on receiving FEMA disaster funds (Sec. 232, Sec. 704).
