by amending section 1170a (MCL 380.1170a), as added by 2016 PA 388.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1170a. (1) ~~By not later than the 2017-2018 school year,~~
2 ~~the~~ **The** department shall ensure that the **recommended** model core

5 education ~~under~~ **described in** section 1278a provide for all of the

1 following:

2 (a) Instruction in cardiopulmonary resuscitation for pupils
3 enrolled in grades 7 to 12. Subject to subsection (5), the content
4 standards and ~~subject area content expectations shall~~ **guidelines**
5 **must** ensure that the psychomotor skills necessary to perform
6 cardiopulmonary resuscitation are incorporated into the
7 instruction. ~~and that the instruction is~~ **For pupils who are able to**
8 **physically participate, the psychomotor skills necessary to perform**
9 **cardiopulmonary resuscitation are strongly encouraged to be**
10 **incorporated into the instruction described in this subdivision**
11 **through the provision of hands-on training. The instruction**
12 **described in this subdivision must be** based on either of the
13 following:

14 (i) An instructional program developed by the American Red
15 Cross or the American Heart Association.

16 (ii) Nationally recognized, evidence-based guidelines for
17 cardiopulmonary resuscitation.

18 (b) Instruction about automated external defibrillators for
19 pupils enrolled in grades 7 to 12.

20 (c) **Instruction for pupils enrolled in grades 7 to 12 that is**
21 **developed by the Stop the Bleed program or the American College of**
22 **Surgeons Committee on Trauma or determined appropriate by the**
23 **department concerning the use of first aid response kits. For**
24 **pupils who are able to physically participate, the instruction**
25 **described in this subdivision is strongly encouraged to be through**
26 **the provision of hands-on training. The first aid response kits**
27 **described in this subdivision must be kits that contain at least**
28 **all of the following:**

29 (i) **A tourniquet.**

1 (ii) Bleeding control dressings.

2 (iii) Compression bandages.

3 (iv) Latex-free protective gloves.

4 (v) Trauma shears.

5 (vi) A marker.

6 (vii) A copy of instructions on the use of the kit as described
7 in this subdivision.

8 (2) The content standards or ~~subject area content expectations~~
9 ~~and~~ guidelines under subsection (1) ~~shall~~ **must** not require a
10 certificated teacher to be an authorized CPR/AED instructor to
11 facilitate, provide, or oversee instruction described in subsection
12 (1)(a) if that instruction does not result in a pupil earning a CPR
13 certification card or status.

14 (3) If instruction described in subsection (1)(a) will result
15 in a pupil earning a CPR certification card or status, that
16 instruction must be taught by an authorized CPR/AED instructor, as
17 applicable.

18 (4) School districts, public school academies, and nonpublic
19 schools are encouraged to use locally available resources to
20 provide the instruction required to meet the content standards or
21 ~~subject area content expectations and guidelines~~ under subsection
22 (1), including, but not limited to, ~~emergency~~ **any of the following:**

23 (a) **Emergency** medical technicians. ~~paramedics, police~~

24 (b) **Paramedics.**

25 (c) **Police** officers. ~~firefighters, representatives~~

26 (d) **Firefighters.**

27 (e) **Licensed registered professional nurses, including school**
28 **nurses.**

29 (f) **Representatives** of the American Heart Association or

1 American Red Cross. ~~, or properly~~

2 **(g) Properly** trained teachers or other school employees **who**
3 **are trained as Stop the Bleed instructors.**

4 (5) The content standards ~~and subject area content~~
5 ~~expectations~~ and guidelines required under subsection (1) ~~shall~~
6 **must** provide that a school or program that provides 100% online
7 instruction is exempt from having to incorporate psychomotor skills
8 into the instruction under this section.

9 (6) As used in this section:

10 (a) "Authorized CPR/AED instructor" means an instructor who is
11 authorized by the American Heart Association, American Red Cross,
12 or a similar nationally recognized association to provide
13 instruction in cardiopulmonary resuscitation that results in the
14 issuance of a CPR certification card or status.

15 (b) "CPR certification card or status" means a card or other
16 credential evidencing successful completion of instruction in
17 cardiopulmonary resuscitation that is issued by the American Heart
18 Association, American Red Cross, or a similar nationally recognized
19 organization using evidence-based guidelines for the teaching of
20 cardiopulmonary resuscitation.
