A bill to prohibit an employer from retaliating against an employee who engages in certain activities that address the employer's response to or management of certain diseases; and to provide remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Communicable disease" means that term as defined in
- 3 section 5101 of the public health code, 1978 PA 368, MCL 333.5101.
- 4 (b) "Damages" means any of the following:

- 1 (i) Actual injury or loss.
- (ii) Reasonable attorney fees and court costs.
- 3 (iii) Punitive damages.
- 4 (c) "Employee" means an individual who performs a service for
- 5 wages or other remuneration under a contract of hire, written or
- 6 oral, expressed or implied.
- 7 (d) "Employer" means a person that has 1 or more employees.
- 8 Employer includes this state, a political subdivision of this
- 9 state, and an agent of the employer.
- 10 (e) "Person" means an individual, partnership, corporation,
- 11 association, or other legal entity.
- 12 (f) "Retaliate" means to do or threaten to do any of the
- 13 following:
- **14** (*i*) Sanction.
- 15 (ii) Reduce pay.
- 16 (iii) Deny a promotion.
- 17 (iv) Terminate employment.
- 18 (v) Publicly demean or embarrass.
- 19 (vi) Any other form of intimidation.
- 20 (g) "Social media" means a service, platform, or website where
- 21 users communicate with one another and share media, such as
- 22 pictures, videos, music, and blogs, with other users free of
- 23 charge.
- Sec. 3. An employer shall not retaliate against an employee
- 25 who criticizes or otherwise raises concerns to any of the following
- 26 regarding the employer's response to or management of any
- 27 communicable disease in the workplace:
- 28 (a) The employer.
- 29 (b) Another employee.

- 1 (c) A department or agency of this state.
- 2 (d) A political subdivision of this state.
- 3 (e) The public, including through the use of social media.
- 4 Sec. 5. (1) An employee who alleges a violation of this act
- 5 may bring a civil action for appropriate injunctive relief or
- 6 damages, or both, not later than 90 days after the alleged
- 7 violation.
- **8** (2) Except as provided in chapter 64 of the revised judicature
- 9 act of 1961, 1961 PA 236, MCL 600.6401 to 600.6475, an action may
- 10 be brought under this subsection in the circuit court for the
- 11 county where the alleged violation occurred, or for the county
- 12 where the employer against whom the civil complaint is filed has
- 13 its principal place of business or is located.
- 14 (3) An employer shall not retaliate or discriminate against an
- 15 employee because the employee has done any of the following:
- 16 (a) Opposed a violation of this act.
- 17 (b) Filed a complaint under this act.
- 18 (c) Testified, assisted, or participated in a civil action
- 19 brought under this act.
- 20 Sec. 7. (1) If a collective bargaining agreement or other
- 21 contract that is inconsistent with this act is in effect for an
- 22 employee on the effective date of this act, this act applies to
- 23 that employee beginning on the date the collective bargaining
- 24 agreement or other contract expires or is amended, extended, or
- 25 renewed.
- 26 (2) This act does not permit the disclosure of information
- 27 that would impair or diminish the rights an individual has to the
- 28 continued protection of confidentiality of communications under the
- **29** law.

- (3) This act does not require an employer to compensate an
 employee for participation in an investigation, hearing, or inquiry
 that results from an action brought under this act.
- 4 (4) This act applies to employees in the classified state
 5 civil service to the extent that it is not inconsistent with
 6 section 5 of article XI of the state constitution of 1963.
