August 21, 2025, Introduced by Reps. Prestin, Bohnak, Markkanen, Fairbairn, Rigas, Borton, BeGole, Outman, Cavitt, Neyer, Beson, Roth, Alexander and Martin and referred to Committee on Natural Resources and Tourism.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 501b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 501b. (1) The Upper Peninsula natural resources
- 2 commission is created. The Upper Peninsula natural resources
- 3 commission is composed of the following members appointed by the
- 4 governor with the advice and consent of the senate:
 - (a) One individual from a list submitted by each member of the

- 1 house of representatives whose district boundaries include the
- 2 Upper Peninsula.
- 3 (b) Two individuals from a list submitted by each member of
- 4 the senate whose district boundaries include the Upper Peninsula.
- 5 (c) Two individuals from a list submitted jointly by all of
- 6 the individuals described in subdivisions (a) and (b).
- 7 (2) The term of office of each member of the Upper Peninsula
- 8 natural resources commission is 2 years. If a vacancy occurs on the
- 9 Upper Peninsula natural resources commission, the governor shall
- 10 make an appointment for the unexpired term in the same manner as
- 11 the original appointment. Each member of the Upper Peninsula
- 12 natural resources commission holds office until the appointment and
- 13 qualification of that member's successor. Not more than half of the
- 14 commission members may be members of the same political party.
- 15 (3) Members of the Upper Peninsula natural resources
- 16 commission shall serve without compensation. However, members of
- 17 the Upper Peninsula natural resources commission may be reimbursed
- 18 for actual and necessary expenses incurred in the performance of
- 19 the official duties as members of the Upper Peninsula natural
- 20 resources commission.
- 21 (4) The Upper Peninsula natural resources commission has all
- 22 of the following powers:
- 23 (a) The authority to issue orders or promulgate rules
- 24 regarding the taking of game or sport fish that have an impact only
- 25 on the Upper Peninsula or that have no significant impact outside
- 26 the Upper Peninsula.
- 27 (b) Any other powers provided by law.
- 28 Enacting section 1. This amendatory act does not take effect
- 29 unless all of the following bills of the 103rd Legislature are
