June 26, 2025, Introduced by Senators HUIZENGA, WEBBER, LAUWERS, DALEY, BELLINO and NESBITT and referred to Committee on Civil Rights, Judiciary, and Public Safety.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 13m of chapter XVII (MCL 777.13m), as amended  
by 2016 PA 549.
