HOUSE RESOLUTION NO. 57

Rep. Mueller offered the following resolution: A resolution to declare April 14-18, 2025, as National Public 1 Safety Telecommunicators Week in the state of Michigan. 2 Whereas, The safety of Michigan's residents and visitors is of 3 utmost importance and emergency response is a critical component in 4 ensuring that safety; and 5 Whereas, 911 public safety telecommunicators are an integral 6 7 part of the emergency response system, playing a crucial and lifesaving role by answering and prioritizing calls for police, fire, 8 and medical assistance, while also providing essential medical 9 10 instructions to callers and coordinating the dispatch of emergency personnel; and 11 12 Whereas, There are approximately 2,200 highly skilled public 13 safety telecommunicators in Michigan serving a population of

2 including the ability to manage high levels of stress, communicate

- 3 clearly and calmly under pressure with life and death situations,
- 4 and multitask effectively at an extreme level to provide efficient
- 5 responses and essential information to responders; and
- 6 Whereas, Michigan public safety telecommunicators process an
- 7 average of 6.5 million 911 calls annually, demonstrating the
- 8 critical nature of their work to ensure the safety and security of
- 9 our communities; and
- 10 Whereas, The first point of contact between the public and
- 11 emergency services during a crisis is public safety
- 12 telecommunicators and their ability to accurately assess and
- 13 respond to emergency situations is essential to the safety and
- 14 well-being of everyone involved; and
- 15 Whereas, Public safety telecommunicators are required to have
- 16 strong communication skills, active listening, quick thinking and
- 17 decision-making, multitasking, knowledge of local resources and
- 18 emergency protocols, and emotional stability, all while keeping the
- 19 responding personnel safe; and
- 20 Whereas, Often, public safety telecommunicators handle
- 21 difficult and traumatic situations, such as death, suicide, abuse,
- 22 and other traumatic events and are required to maintain accuracy
- 23 and composure in high pressure situations; and
- 24 Whereas, National Public Safety Telecommunicators Week (NPSTW)
- 25 initially started in 1981 by the Contra Costa County Sheriff's
- 26 Office in California. In 1994, President William J. Clinton signed
- 27 a Presidential Proclamation declaring the second week of April as
- 28 NPSTW; and

Whereas, This week is a time to celebrate and thank 1 2 telecommunications personnel across Michigan who serve our communities, citizens, and public safety personnel 24 hours a day, 3 4 seven days a week; now, therefore, be it Resolved by the House of Representatives, That the members of 5 6 this legislative body declare April 14-18, 2025, as National Public 7 Safety Telecommunicators Week in the state of Michigan. We 8 acknowledge public safety telecommunicators as first responders for 9 their vital and life-saving roles in emergency response and their 10 highly specialized skill set; and be it further 11 Resolved, That we express our deep appreciation to all public safety telecommunicators in Michigan for their unwavering 12 dedication, professionalism, and exceptional service to our 13 14 communities. We also recognize the unique skills necessary for them 15 to adapt to changing circumstances and navigate complex and rapidly-evolving situations. 16
