## GENERAL SALES TAX ACT (EXCERPT) Act 167 of 1933

## 205.58 Consolidated returns.

Sec. 8.

Any person engaging in 2 or more places in the same business or businesses taxable under this act, shall file a consolidated return covering all the business activities engaged in within this state.
